5. Market situation

Information from the Commission

<u>The SCA</u> took note of the update provided by the Commission on the market situation, notably in the dairy, pigmeat and fruit and vegetables sectors, and of the implementation of the package of measures endorsed in March as well as of its explanations regarding State aid related measures. The SCA also took note of the preliminary questions and positions of delegations, and of the Commission's reaction.

The SCA will revert to this issue at its next meetings and at the Council in April.

6. SRSP (Structural Reform Support Program)

Information from the Commission

The Commission presented technical details about its proposal on the SRSP (doc. 14790/15), in particular with regard to the amendment of the EAFRD Regulation (No 1305/2013), which is currently being negotiated in the Financial Counsellors Working Party. During the discussion, certain delegations sought information about the implementation of the EU budget: the Commission's monthly implementation reports on the use of budgetary allocations can be found at http://ec.europa.eu/budget/biblio/documents/2016/2016_en.cfm. This information is also forwarded by the GSC to delegations in the Council's Budget Committee. The GSC also forwards to delegations (AGRI, AGRIFIN) the regular reports from the Commission on EAGF expenditure Early Warning System, with the last one distributed on 5 February (doc. 5878/16).

7. European Fund for Strategic Investments (EFSI)

Information/presentation from the Commission

<u>The Commission</u> informed delegations how EFSI could help supporting strategic investments in the agriculture sector and overcoming current market failures in the sector. <u>The Commission representative</u> is expected to inform Ministers likewise at the forthcoming "Agriculture and Fisheries" Council on 11 April.

8. G20 Agriculture Deputies Meeting

Information from the Commission

<u>The SCA</u> took note of the information provided by the Commission on the G20/G7 activities in the field of agriculture and of next steps, in particular as regards the preparation of EU Guidelines for the upcoming G20 Agriculture Ministerial to which <u>the SCA</u> will revert on 18 April, of delegations' comments, as well as of the Commission's update on the calendar for the next steps in the EU-Mercosur negotiations and of delegations' remarks in this respect.

With regard to three recent special reports from the European Court of Auditors (ECA), the Presidency invited those delegations, who wish to discuss these reports in the SCA to produce a paper clearly indicating which aspects in these reports go beyond the remit of AGRIFIN, e.g. as regards possible longer-term policy or CAP legislative implications.

<u>The Presidency</u> informed the SCA on the preparation of the "Agriculture and Fisheries" Council meeting on 11 April 2016 in Luxembourg as well as on the next SCA meeting on 18 April.
