# amending Decision 2012/389/CFSP on the European Union Capacity Building Mission in Somalia (EUCAP Somalia)

### THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union and in particular Article 42(4) and Article 43(2) thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- On 16 July 2012, the Council adopted Decision 2012/389/CFSP<sup>1</sup> concerning the European Union Mission on Regional Maritime Capacity Building in the Horn of Africa (EUCAP NESTOR).
- (2) On 12 December 2016, the Council adopted Decision (CFSP) 2016/2240<sup>2</sup>, which amended the Mission's mandate to focus it on capacity building in Somalia and changed the Mission's name to EUCAP Somalia.
- (3) On 10 December 2018, the Council adopted Decision (CFSP) 2018/1942<sup>3</sup> amending Decision 2012/389/CFSP to extend EUCAP Somalia and provide it with a financial reference amount for the period from 1 January 2019 until 31 December 2020.

- (5) Decision 2012/389/CFSP should be amended by increasing the financial reference amount,HAS ADOPTED THIS DECISION:

#### Article 1

In Article 13(1) of Decision 2012/389/CFSP, the seventh paragraph is replaced by the following:

'The financial reference amount intended to cover the expenditure related to EUCAP Somalia for the period from 1 January 2019 to 31 December 2020 shall be EUR 71 189 005,32.'.

## Article 2

This Decision shall enter into force on the date of its adoption.
