Subject:	Draft amending budget No 2 to the general budget 2015 accompanying the Proposal for a Council regulation amending Council Regulation (EU, Euratom) No 1311/2013 of 2 December 2013 laying down the multiannual financial framework for the years 2014-2020		

1. On 20 January 2015, the Commission submitted draft amending budget (DAB) No 2/2015 accompanying the Proposal for a Council Regulation amending Council Regulation (EU, Euratom) No 1311/2013 of 2 December 2013 laying down the multiannual financial framework for the years 2014-2020 (MFF Regulation).

The purpose of this DAB is to budget commitment appropriations (c/a) that are transferred to 2015 in line with Article 19 of the above-mentioned MFF Regulation. It proposes to increase c/a for an amount of EUR 16 476.4 million under sub-heading 1b (*Economic, social and territorial cohesion*), heading 2 (*Sustainable growth: Natural resources*) and heading 3 (*Security and citizenship*). It also proposes an increase of EUR 2.5 million in c/a for the Instrument for Pre-Accession Assistance under heading 4 (*Global Europe*) in order to maintain the same level of contributions from heading 4 and sub-heading 1b to European Territorial Cooperation programmes.

This DAB does not propose any changes in payment appropriations.

 - have the Council's position published in the *Official Journal of the European Union* as set out in Annex 1.
