**"In the exceptional circumstances and mindful of the importance of this instrument, in particular the need to ensure there is a dedicated secure travel document for the return of third-country nationals subject to a return decision, Ireland will not insist upon its right to exercise an option to notify the President of the Council of its wish to participate in the adoption and application of the Proposal for a Regulation in accordance with the provisions of Article 3 of the Protocol 21 on the Position of the United Kingdom and Ireland in respect of the area of Freedom, Security and Justice annexed to the Treaty on European Union and the Treaty on the Functioning of the European Union. Rather, Ireland declares its intention, subject to Parliamentary approval as required by the Constitution of Ireland, to consider exercising the option provided in Article 4 of the said Protocol 21 and to consider indicating its acceptance of the measure after its adoption."**
