Subject:	Draft REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL laying down specific and temporary measures in view of COVID-19 outbreak and concerning the validity of certain certificates, licences and authorisations and the postponement of certain periodic checks and training in certain areas of transport legislation <b>(first reading)</b> - Decision to use the written procedure for the adoption of the legislative act - Decision to derogate from the 8-week period provided for in Article 4 of Protocol 1 to the TFEU on the role of national parliaments in the EU

---

1. On 29 April 2020 the Commission sent its proposal<sup>1</sup>, based on Articles 91 and 100(2) TFEU, to the Council.
2. The European Economic and Social Committee has been consulted and is set to reply shortly.
3. The Committee of the Regions has been consulted and is set to reply shortly.
4. The European Parliament will adopt its position at first reading on the Commission proposal at its plenary on 13-16 May 2020.

5. Given the urgency entailed by the exceptional circumstances justifying the proposed measures, it will only be possible to adopt the Regulation via the written procedure.
6. In view of the above, the Permanent Representatives Committee is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision 2020/556<sup>2</sup>, that the Council uses the written procedure:
- for the adoption of the draft Regulation of the European Parliament and of the Council laying down specific and temporary measures in view of COVID-19 outbreak and concerning the validity of certain certificates, licences and authorisations and the postponement of certain periodic checks and training in certain areas of transport legislation, as set out in document PE- CONS 16/20<sup>3</sup>; and
  - to derogate, on the basis of the second subparagraph of Article 3(3) of the Council's Rules of Procedure, from the eight-week period referred to in the first subparagraph of that Article.
