3. External Aspects of Migration

The Council had an exchange of views on the activities undertaken by the European Union concerning the external dimension of the migration, notably the possible extension of Operation Sophia, consideration on the provision of training to Libyan coast guards, support for securing the southern border of Libya and enhanced support for G5 Sahel countries including through a possible regionalisation of CSDP EUCAP mission. The Council discussed the outcome of High level political dialogues on migration with a focus on Return and Readmission and on economic opportunities. The Council agreed to revert regularly to the subject.

4. EU Regional Strategy for Syria and Iraq as well as the ISIL/Da'esh threat

This item was postponed to a forthcoming Council meeting.

5. Eastern Partnership

<u>The Council</u> had an exchange of views focusing on the challenges and commitments in the framework of the Eastern Partnership and on reaching a shared EU approach towards preparing the Eastern Partnership Foreign Ministers meeting on 23 May 2016.

In the presence of NATO Secretary General Stoltenberg, <u>High Representative</u> <u>Mogherini</u> briefed the Council on possible EU efforts in support of Afghanistan's security sector reform beyond 2016.

In the presence of NATO Secretary General Stoltenberg, <u>High Representative Mogherini and Commissioner Bienkowska</u> presented the Joint Communication "Joint Framework on countering hybrid threats - a European response". <u>Ministers</u> exchanged views and adopted Council conclusions on the topic, welcoming the Joint Communication.

10. Capacity Building for Security and Development

<u>Ministers</u> exchanged views on the state of play of work in the field of Capacity Building in support of Security and Development. <u>High Representative Mogherini</u> confirmed that a legislative proposal to operationalise the initiative should be ready by June 2016.

Central European Defence Cooperation

<u>The Austrian Minister of Defence</u> presented the recent declaration of Central European Defence Cooperation countries, also signed by three non-EU Western Balkans nations, presenting options to tackle the challenges posed by the refugee and migration crisis.
