#### **I. INTRODUCTION**

The rapporteur, PIOTROWSKI (ECR, PL), presented a report on the proposal for a Regulation on behalf of the Committee on Regional Development. The report contained 1 amendment (amendment number 1) to the proposal.

In addition, the Greens political group tabled 1 amendment (amendment number 2), the EFDD group tabled 1 amendment (amendment number 3) and four GUE MEPs (Ms KYLLÖNEN-FI, Mr FERREIRA-PT, Mr PIMENTA LOPES-ES and Mr VIEGAS-PT) tabled 1 amendment (amendment number 4).

## II. VOTE

When it voted on 4 April 2019, the plenary adopted amendment 1 to the proposal for a Regulation. No other amendments were adopted.

The Commission's proposal as thus amended constitutes the Parliament's first-reading position which is contained in its legislative resolution as set out in the Annex hereto<sup>1</sup>.

### **(Ordinary legislative procedure: first reading)**

*The European Parliament,*

- having regard to the Commission proposal to Parliament and the Council (COM(2018)0614),
  - having regard to Article 294(2) and Article 177 of the Treaty on the Functioning of the European Union, pursuant to which the Commission submitted the proposal to Parliament (C8-0396/2018),
  - having regard to Article 294(3) of the Treaty on the Functioning of the European Union,
  - having regard to the opinion of the European Economic and Social Committee of 24 January 2019<sup>2</sup>,
  - after consulting the Committee of the Regions,
  - having regard to Rule 59 of its Rules of Procedure,
  - having regard to the report of the Committee on Regional Development (A8-0181/2019),
1. Adopts its position at first reading hereinafter set out;
  2. Calls on the Commission to refer the matter to Parliament again if it replaces, substantially amends or intends to substantially amend its proposal;
  3. Instructs its President to forward its position to the Council, the Commission and the national parliaments.
