Having regard to the proposal from the European Commission,

Whereas:

- The Air Transport Agreement between the United States of America, of the one part, and the European Community and its Member States, of the other part¹ (hereinafter the 'Air Transport Agreement') was signed on 25 and 30 April 2007 and was amended by the Protocol to amend the Air Transport Agreement between the United States of America and the European Community and its Member States, signed on 25 and 30 April 2007² (hereinafter the '2010 Protocol'). The 2010 Protocol was signed by the United States of America and the European Union and its Member States on 24 June 2010.
- (2) In accordance with the second subparagraph of Article 6(2) of the Act of Accession of the Republic of Croatia³, the accession of Croatia to the Air Transport Agreement is to be agreed by means of a Protocol to that Agreement, concluded between the Council, acting unanimously on behalf of the Member States, and the United States of America.
- On 14 September 2012, the Council authorised the Commission to open negotiations with the United States of America with a view to concluding a Protocol amending the Air Transport Agreement as amended by the 2010 Protocol to take account of the accession of Croatia to the European Union (hereinafter the 'Protocol').

- (4) The negotiations were successfully concluded and the Protocol was initialled on 8 March 2019.
- The Protocol should be signed and should be applied on a provisional basis in accordance (5) with Article 4 thereof, subject to its conclusion at a later date,

Article 1

The signing of the Protocol amending the Air Transport Agreement between the United States of America and the European Community and its Member States signed on 25 and 30 April 2007, as amended by the Protocol to amend the Air Transport Agreement between the United States of America and the European Community and its Member States, signed on 25 and 30 April 2007, signed by the United States of America and the European Union and its Member States on 24 June 2010, to take account of the accession to the European Union of the Republic of Croatia (hereinafter the 'Protocol'), is hereby authorised on behalf of the Union and its Member States, subject to the conclusion of the said Protocol.¹
