Whereas:

- (1) On 11 July 2017, the Council adopted Decision (CFSP) 2017/1252¹.
- (2) Article 5(2) of Decision 2017/1252 provides for a 36-month implementation period from the date of the conclusion of the financing agreement referred to in Article 3(3) of that Decision, for the activities referred to in Article 1 thereof.
- (3) The financing agreement with the Organization for Security and Co-operation in Europe (OSCE) was concluded on 30 August 2017, and therefore expires on 30 August 2020.
- (4) On 23 April 2020, the OSCE requested a six-month extension of the implementation period of Decision (CFSP) 2017/1252, due to the temporary suspension of a number of activities in support of the strengthening of chemical safety and security in Ukraine because of the COVID-19 pandemic.
- (5) The continuation of the activities referred to in Article 1 of Decision (CFSP) 2017/1252 does not have any implication as regards financial resources until 28 February 2021.
- (6) Decision (CFSP) 2017/1252 should be amended accordingly,
