On behalf of the President of the European Committee of the Regions (CoR), Vasco Alves Cordeiro, I would like to thank you for your referral request by your referral letter SGS 24/001218 to the CoR, dated 29 February 2024, regarding the following dossier:

Proposal for a Directive of the European Parliament and of the Council amending Directive 2009/38/EC as regards the establishment and functioning of European Works Councils and the effective enforcement of transnational information and consultation rights [COM(2024) 14 final].
