Statement by Luxembourg

"Le Luxembourg regrette que le nouveau Consensus européen pour le développement, qui définira le cadre à moyen terme de la coopération au développement de l'Union européenne et de ses Etats membres, se soit éloigné de l'objectif principal de sa raison d'être, à savoir l'éradication de la pauvreté, tout en plaçant cet objectif dans le nouveau cadre de l'Agenda 2030.

Au cours des négociations, le Luxembourg avait notamment exprimé ses inquiétudes quant à la mise en place de conditionnalités et l'insertion d'une référence aux réadmissions ainsi qu'en ce qui concerne le respect des critères du CAD de l'OCDE dans le contexte du nexus sécurité - développement.

Par ailleurs, le Luxembourg a soutenu la demande du Parlement européen d'introduire un mécanisme de suivi pour parvenir à l'objectif fixé de longue date de consacrer 0,7% du revenu national brut (RNB) à l'APD, conformément à l'engagement des Etats membres de l'ONU en 1970, lequel a été réaffirmé à maintes reprises depuis lors par l'Union européenne et ses Etats membres.

Toutes ces demandes ne sont pas ou peu reflétées dans le texte. Le nouveau Consensus marquera un net recul par rapport à celui de 2005, ce que le Luxembourg regrette vivement."

Statement by Germany, Slovakia and Sweden

"This Decision authorizes the Commission to submit the proposal to the Secretariat of the Convention on the conservation of migratory species of wild animals (CMS) on behalf of the Union. As a Decision of the Council, it does not deal with the competences of Member States involved in the listing proposal. This does not change the fact that the matter at hand is a matter of shared environmental competence under Article 4 (2) e) of the Treaty on the Functioning of the EU (TFEU). We thus accept the Decision with the understanding that the proposals will be dealt with in the same manner as the proposals of the EU and its 28 Member States for the last 11th Conference of the Parties of CMS. In particular, the listing proposal at the 11th COP for listing *coracias garrulus*, a bird listed in Annex I of the Birds Directive (2009/147/EC), on the Appendix I of CMS was proposed by the European Union and its 28 Member States."
