Subject:	Draft amending budget No 4 to the general budget for 2015 accompanying the proposal to mobilise the European Union Solidarity Fund for Romania, Bulgaria and Italy

1. On 15 April 2015, the <u>Commission</u> submitted to the Council draft amending budget (DAB) No 4 to the general budget for 2015 regarding the mobilisation of the EU Solidarity Fund for a total amount of EUR 66 505 850 in commitment and payment appropriations.

The objective of this proposal is to provide financial assistance to Romania, Bulgaria and Italy in response to flooding disasters that occurred between April and November 2014.

The corresponding appropriations are to be recorded under Article 13 06 01 (EU Solidarity Fund - Assistance to Member States in the event of a major natural disaster with serious repercussions on living conditions, the natural environment or the economy).

 European Parliament and to approve the draft letter in Annex 2 to that effect;
 - have the Council's position published in the Official Journal of the European Union as set out in Annex 1.
