Proposta għal Regolament tal-Parlament Ewropew u tal-Kunsill li jemenda r-Regolament tal-Kunsill (KE) Nru 1225/2009 dwar il-protezzjoni kontra l-importazzjonijiet li huma l-oġġett ta' dumping minn pajjiżi mhux membri tal-Komunità Ewropea, u r-Regolament tal-Kunsill (KE) Nru 597/2009 dwar il-protezzjoni kontra importazzjonijiet sussidjati minn pajjiżi li mhumiex membri tal-Komunità Ewropea

I. VOT

Billi ma giet adottata ebda emenda, il-President tal-Parlament Ewropew iddikjara l-pożizzjoni tal-Kunsill fl-ewwel qari bħala approvata.

It-test tar-risoluzzjoni leġislattiva tal-Parlament Ewropew huwa mehmuz ma' din in-nota.

II. ADOZZJONI TA' ATTI LEĠISLATTIVI WARA T-TIENI QARI TAL-PARLAMENT EWROPEW

Billi l-Parlament Ewropew approva l-pożizzjoni tal-Kunsill fl-ewwel qari, l-att inkwistjoni jitqies li ġie adottat fil-formulazzjoni li tikkorrispondi għall-pożizzjoni tal-Kunsill fl-ewwel qari, kif previst fl-Artikolu 294 (7)(a) TFUE.

Wara l-firma mill-President tal-Parlament Ewropew, il-President tal-Kunsill u s-Segretarji Ġenerali taż-żewġ Istituzzjonijiet, l-att inkwistjoni ser jiġi ppubblikat f'*Il-Ġurnal Uffiċjali tal-Unjoni Ewropea*.

European Parliament legislative resolution of 30 May 2018 on the Council position at first reading with a view to the adoption of a Regulation of the European Parliament and of the Council amending Regulation (EU) 2016/1036 on protection against dumped imports from countries not members of the European Union and Regulation (EU) 2016/1037 on protection against subsidised imports from countries not members of the European Union (05700/1/2018 – C8-0168/2018 – 2013/0103(COD))

(Ordinary legislative procedure: second reading)

The European Parliament,

- having regard to the Council position at first reading (05700/1/2018 – C8 – 0168/2018)
 - having regard to its position at first reading¹ on the Commission proposal to Parliament and the Council (COM(2013)0192),
 - having regard to Article 294(7) of the Treaty on the Functioning of the European Union,
 - having regard to the provisional agreement approved by the committee responsible under Rule 69f(4) of its Rules of Procedure,
 - having regard to Rule 67a of its Rules of Procedure,
 - having regard to the recommendation for second reading of the Committee on International Trade (A8-0182/2018),
1. Approves the Council position at first reading;
 2. Notes that the act is adopted in accordance with the Council position;
 3. Instructs its President to sign the act with the President of the Council, in accordance with Article 297(1) of the Treaty on the Functioning of the European Union;

4. Instructs its Secretary-General to sign the act, once it has been verified that all the procedures have been duly completed, and, in agreement with the Secretary-General of the Council, to arrange for its publication in the *Official Journal of the European Union*;
 5. Instructs its President to forward its position to the Council, the Commission and the national parliaments.
