Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 58(2)(b), Article 110(1) and Article 181 thereof,

Whereas:

- The Agreement on the European Economic Area¹ ('the EEA Agreement') entered into force **(1)** on 1 January 1994.
- **(2)** Pursuant to Article 98 of the EEA Agreement, the EEA Joint Committee may decide to amend, inter alia, Protocol 31 to the EEA Agreement.
- (3) Protocol 31 to the EEA Agreement contains provisions on cooperation in specific fields outside the four freedoms.
- **(4)** It is appropriate to continue the cooperation of the Contracting Parties to the EEA Agreement in Union actions funded from the general budget of the European Union regarding the preparatory action on Defence research.
- (5) Protocol 31 to the EEA Agreement should therefore be amended in order to allow for that extended cooperation to take place from 1 January 2019.
- (6) The position of the Union within the EEA Joint Committee should therefore be based on the attached Draft decision,

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Articles 86 and 98 thereof,

Whereas:

- (1) It is appropriate to continue the cooperation of the Contracting Parties to the EEA Agreement in Union actions funded from the general budget of the European Union regarding the preparatory action on Defence research.
- Protocol 31 to the EEA Agreement should therefore be amended in order to allow for that (2) extended cooperation to take place from 1 January 2019,

Article 1

In paragraph 13(a) of Article 1 of Protocol 31 to the EEA Agreement, the words 'and 2018' are replaced by the words ', 2018 and 2019'.

Article 2

This Decision shall enter into force on the day following the last notification under Article 103(1) of the EEA Agreement*.

It shall apply from 1 January 2019.
