#### 3. **FAROE ISLANDS**

- 3.1 Proposal for a Council Decision on the position to be taken, on behalf of the EU, in the Joint Committee of the EU-Faroe Islands Free Trade Agreement concerning (a) the inclusion of frozen and preserved sprat (Sprattus sprattus) in the Annex to Protocol 1 of the Agreement; (b) the inclusion in Protocol 4, Article 2 of a tariff quota of 40 tonnes of sheep meat from the EU to the Faroe Islands, increasing to 80 tons after three years; and (c) the removal of the restrictions on added gluten in fish feed exported from the Faroe Islands to the EU (Protocol 4, Article 1)
  - discussion

The EFTA Working Party will start the examination of the above proposal with a view to finding an agreement.
