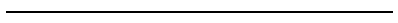

b) PSC certificate

Admission to the meeting will be granted only to those delegates for whom the GSC Safety and Security Directorate has a record of a PSC up to level S-UE/EU-S or who can present a valid original of a PSC certificate issued by their National Security Authority or by other competent national authorities.

Only in case a PSC certificate for the delegate concerned has not yet been transmitted to the GSC Security Clearances Office, a copy should be sent by the delegate's National Security Authority or other competent national authority or by the sending organisation's security officer to security.clearances@consilium.europa.eu also by **18 June 2026, c.o.b.**, *indicating the reference of the meeting in the Subject field* for quicker treatment.

It is in the interest of the participants to ensure that their PSC certificate has not expired.

Please note that PSC certificates sent by the delegates themselves will not be accepted.

During the meeting, all electronic devices must be placed in lockers outside the meeting room.
