Only in case a PSC certificate for the delegate concerned has not yet been transmitted to the GSC Security Clearances Office, a copy should be sent by National Security Authority or other competent national authority or your organisation's security officer to [security.clearances@consilium.europa.eu](mailto:security.clearances@consilium.europa.eu) also by Tuesday 19 May 2025 12:00<sup>3</sup>.

It is in the interest of the participants to ensure that their PSC certificate has not expired.
