Delegations are informed that the written procedure opened by CM 2955/22 + COR 1 of 2 June 2022 was completed on 3 June 2022 at 9.25 and that all delegations voted in favour of:

I. Council Decision and Implementing Regulation concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine

1. the adoption of the Council Decision amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine, as set out in document 8668/22 REV 1;
2. the adoption of the Council Implementing Regulation implementing Regulation (EU) No 269/2014 concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine, as set out in document 8670/22 REV 1;
3. the approval of the notices as set out in Annexes I and II to document 8671/22 REV 1;
4. the approval of the template for the notification letter for persons whose address is known, as set out in Annex III to document 8671/22 REV 1.

Therefore, the above Council Decision and Implementing Regulation are adopted and the notices and the template letter are approved.

II. Council Implementing Decision and Implementing Regulation concerning restrictive measures in view of the situation in Belarus and the involvement of Belarus in the Russian aggression against Ukraine

1. the adoption of the Council Implementing Decision implementing Decision 2012/642/CFSP concerning restrictive measures in view of the situation in Belarus and the involvement of Belarus in the Russian aggression against Ukraine, as set out in document 8639/22;

2. the adoption of the Council Implementing Regulation implementing Article 8a(1) of Regulation (EC) No 765/2006 concerning restrictive measures in view of the situation in Belarus and the involvement of Belarus in the Russian aggression against Ukraine, as set out in document 8641/22;
3. the approval of the notices as set out in Annexes I and II to document 8642/22 REV 1;
4. the approval of the template for the notification letter for persons whose address is known, as set out in Annex III to document 8642/22 REV 1.

Therefore, the above Council Decision and Implementing Regulation are adopted and the notices and the template letter are approved.

4. approve the template for the notification letter for the entities added to Annex IX to Decision 2014/512/CFSP and to Annex XV to Regulation (EU) No 833/2014, as set out in Annex II to document 8679/22 REV 1;
5. approve the Council statement as set out in document 9717/22.

Therefore, the above Council Decision and Implementing Regulation are adopted and the notices and the template letter are approved.
