

Adoption of the legislative act

STATEMENT BY POLAND

“On the whole, Poland supports the overall objectives of the Commission proposal and the general trend of stimulating reduction efforts by increasing existing standards or formulating new ones.

The Polish government agrees on the need to take action to reduce CO₂ emissions from the transport sector.

However, in Poland’s view, the reduction of vehicle exhaust emissions should be carried out in a balanced manner, taking into account market capabilities, having regard to both the technological conditions of vehicle and vehicle equipment manufacturers and the economic dimension concerning the financial capacities of vehicle purchasers and users and the country’s citizens.

At the same time, Poland notes that the proposed rules could pose a significant challenge and burden for manufacturers and local authorities. For semi-trailer manufacturers, given the available technology, the proposed rules may even be impossible to implement.

Compared to the position adopted in the Council’s general approach, Poland notes in particular the unfavourable development towards stricter reduction requirements for semi-trailers and urban buses. Poland therefore opposes the adoption of the Regulation.”

STATEMENT BY SLOVAKIA

“Slovakia is aware of the need to decarbonise road transport in the European Union and its Member States. However, the final agreement reached between the Council and the Parliament on the proposed Regulation is still overly ambitious in terms of targets and the deadlines for meeting them.

We consider it important to draw attention to the following points, which, in our view, have been omitted from the final agreement:

Firstly, the principle of technological neutrality has not been taken into account in the Regulation. Relying exclusively on electric and hydrogen heavy-duty vehicles that are not available on a large scale could be a double-edged sword due to legitimate concerns as to whether these are the most appropriate technologies. This problem is accentuated by the lack of recharging points for the heavy-duty vehicle segment, which appears to be a significant obstacle both now and in the near future, and other practical implications are questionable.

Secondly, the assessment of the measures supported by Slovakia, particularly the potential and role of renewable CO₂-neutral fuels, the introduction of a carbon correction factor and the assessment of CO₂ emissions throughout the entire life cycle of new heavy-duty vehicles only in the review clause, seems to us to be insufficient. From our perspective, addressing all the above elements at a later stage creates a disadvantage for other alternative fuels with decarbonisation potential in the road transport sector.

Despite discussions on what for Slovakia are essential elements, the final wording of the Regulation has, from our perspective, not improved. We are therefore unable to support the final text agreed in the Regulation amending Regulation (EU) 2019/1242 as regards strengthening the CO₂ emission performance standards for new heavy-duty vehicles and integrating reporting obligations, amending Regulation (EU) 2018/858 and repealing Regulation (EU) 2018/956.”

STATEMENT BY GERMANY

“The Federal Government states for the record that Germany also considers it necessary to relieve farmers of red tape and also supports a permanent arrangement for GAEC 8. However, the measures taken in this regard must not undermine the objectives of EU policy, namely the Green Deal, and the steps taken so far in terms of EU agricultural support towards transforming the agri-food system. The lowering of standards associated with some of the Commission’s proposals weakens the CAP as a key European instrument for implementing the Green Deal if no accompanying measures are taken, particularly to maintain biodiversity ambitions.”

**STATEMENT BY THE COMMISSION on the monitoring of imports of grain from Ukraine
on the occasion of the adoption of Regulation 2024/xxxx⁵**

“Russia’s war of aggression against Ukraine has disrupted pre-existing supply chains. The EU is providing support to Ukraine to resume normal flow of grain and other goods, especially through the Solidarity Lanes, and to ensure that exports of grain can reach their destination, including in particular in third markets, to support global food security.

The Commission is committed to supporting Ukraine while also preserving the interest of the EU grain producers and ensuring a proper functioning of the grain market in the EU.

Given the importance of grain production and grain markets, the Commission will pay particular attention to the monitoring of imports of grain, in particular wheat, and notably to the concentration of such imports in Member States neighbouring Ukraine. In its regular dialogue with Ukraine, the Commission will address any issues brought to light by the monitoring. The Commission recalls that imports from Ukraine can be subject to surveillance under Chapter IV of Regulation (EU) 2015/478 of the European Parliament and the Council of 11 March 2015 on common rules for imports, which can take the form of import licensing, if the trend in imports threatens to cause injury to Union producers and if the interests of the Union so require. In this regard, the Commission will use the tools at its disposal as needed. The Commission will continue to report regularly to Member States on the results of the regular dialogue with Ukraine.

For products covered by ATMs, the Commission recalls that the Regulation also provides for a reinforced safeguard mechanism. For the first time, the Commission has introduced the possibility and is ready to activate this mechanism in the event of adverse effects on the market of one or several Member States and not only for the EU market as a whole. In this regard, the Commission will use to the full extent its powers to initiate ex officio the reinforced safeguard mechanism for imports of wheat from Ukraine.

The Commission recalls that, in 2022 and 2023, it adopted measures to support European farmers in all Member States, notably in the Member States neighbouring Ukraine.”

STATEMENT BY THE COMMISSION on the Review Process under Article 29 of the Association Agreement on the occasion of the adoption of Regulation 2024/xxxx⁶

“The Commission confirms that, as soon as the new ATMs are adopted by the co-legislators, it will take the necessary steps under Article 29 of the Association Agreement to pursue, through consultations with Ukraine, the process of reciprocal tariff liberalisation.

The Commission will closely involve the European Parliament and will keep it informed of the progress of those consultations with Ukraine. The Commission will take due account of possible comments of the European Parliament in that respect.

The Commission recalls that these working modalities do not constitute a precedent for review clauses in any other agreement and do not deviate from Article 218 TFEU.

The outcome of this process will provide economic certainty and stable trade to both Ukraine and the EU, to farmers and businesses. This will also be an important step in the reconstruction of Ukraine and further integration into the EU internal market, as part of the country’s future accession to the Union.”

STATEMENT BY THE COUNCIL

“The Commission presented a statement on the Review Process under Article 29 of the Association Agreement on the occasion of the adoption of Regulation 2024/xxx indicating that, as it takes the necessary steps under Article 29 of the Association Agreement to pursue the process of reciprocal tariff liberalisation, it will closely involve the European Parliament and keep it informed of the progress of the consultations with Ukraine. Moreover, the Commission indicated that it will take due account of possible comments of the European Parliament in that respect.

The Council recalls that this process must be undertaken in accordance with the procedure set out in Article 218 TFEU, in particular paragraph 9. The close involvement of the European Parliament in this process, as described in the Commission statement, is not foreseen in Article 218 TFEU and would lead to a modification of the institutional balance resulting from the Treaties.

In this context, as indicated in its statement on the Framework Agreement between the European Parliament and the Commission (2010/C 287/01), the Council will submit to the Court of Justice any act or action of the European Parliament or the Commission performed in application of the Commission’s statement that would have an effect contrary to the interests of the Council and the prerogatives conferred upon it by the Treaties.”
