Subject: Frontex Programming Document 2023-2025: Consultation of the Council in line with Regulation (EU) 2019/1896  
- Approval of a letter

---

Pursuant to Article 102(1) of Regulation (EU) 2019/1896 on the European Border and Coast Guard, the management board of Frontex shall adopt by 30 November of each year a single programming document containing the Agency's multiannual programming and annual programming for the following year. The single programming document shall be adopted taking into account a positive opinion of the Commission. The multiannual programming shall be adopted after having consulted the European Parliament and the Council.

The General Secretariat of the Council distributed the Frontex Programming Document 2023-2025 to delegations on 21 April 2022<sup>1</sup>. It requested written comments from the Member States and Schengen Associated Countries regarding the programming document.

Delegations were invited to send their comments to the Presidency and the General Secretariat of the Council by 1 June 2022. No comments were received.

In the light of the above, Coreper is invited to approve the letter to Frontex as set out in the Annex to this note.
