#### Ad "B" item 3: Directive on consumer credits Adoption of a general approach

#### JOINT STATEMENT BY ESTONIA AND LITHUANIA

"Estonia and Lithuania welcome the main objective of the Commission proposal to modernise and strengthen consumer credit rules in order to cater for changes brought about by digitalisation whilst creating a high level of consumer protection and helping the internal market function smoothly. However, this should be achieved by a reasonable balance that among other things avoids unnecessary burden on traders and disproportionate interference in well-functioning markets.

In this context, we welcome the final compromise text of the French Presidency, because there are many aspects that take into account these underlying principles. However, we have from the beginning supported to exclude credits free of interest and without any other charges from the scope of the Directive as is currently the case. In our view, including these types of credits would bring along disproportionate burden for the traders and to supervisory authorities and might deprive consumers from offers beneficial to them. Even though we would have preferred a more ambitious approach in this regard, we can support the text, which allows applying proportionate regime and some targeted exclusions of this type of credits.

Therefore, we would urge to preserve the delicate balance we have achieved and to consider the above mentioned arguments in the course of the upcoming negotiations with the European Parliament."

#### STATEMENT BY POLAND

#### STATEMENT BY THE COUNCIL

#### on Russian military aggression against Ukraine and its impact on R&I

"The Council stresses that Russian military aggression against Ukraine grossly violates international law and is causing massive loss of life and injury to civilians. Russia is directing attacks against the civilian population and is targeting civilian objects, including scientific institutions, such as universities, research institutes and libraries. The war has jeopardized the research and innovation (R&I) landscape of Ukraine and compromised sound scientific relations with the R&I communities of both countries.

The Council recalls that the respect for human rights and fundamental freedoms as well as promoting peaceful relations among nations forms the foundation of international cooperation in the field of R&I and that the violation of these principles and values poses a serious threat to individual researchers.

The Council welcomes the quick reaction of the Commission and Member States to launch the portal <u>ERA4Ukraine</u> under the Euraxess network as a one-stop shop for information on support to researchers of Ukraine by the EU, its Member States and Associated Countries. The Council acknowledges that ERA4Ukraine is just one of the many on-going initiatives of the Commission, Member States, various organisations as well as individual members of the EU R&I community to support Ukrainian researchers and students and calls for further actions towards Ukraine. The Council welcomes the decision to suspend existing and new cooperation with public entities in Russia and Belarus initiated by the Commission within the European Framework Programmes for Research and Innovation and other relevant EU programmes, as well as measures taken at Member States' level. The Council invites the Commission to regularly provide it with information in this context.

The Council stresses therefore the need to further implement coordinated mechanisms, taking into account existing national measures, in order to support researchers and students who are forced to flee or are under threat due to Russia's military aggression. Moreover, the Council highlights the necessity to put in place appropriate support to allow Ukraine to maintain and regain its higher education and scientific capacities.

The Council highlights in that context the relevance of science diplomacy as an important tool for the pursuit of values and principles of international cooperation as well as for linking up R&I policies and overarching policy goals."
