Ester RÜNKLA, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Ester RÜNKLA as an alternate member of the Management Board of the above Foundation in the category of government representatives (for Estonia).
2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75, members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Estonia has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2023:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound)¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019², 25 June 2019³, 8 July 2019⁴, 16 September 2019⁵ and 14 June 2021⁶, the Council appointed the members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as an alternate member in the category of government representatives has fallen vacant as a result of the resignation of Ms Ester RÜNKLA.
- (3) The government of Estonia has nominated a candidate for the vacant seat,
