STATEMENT BY THE COMMISSION

"The Commission confirms that it will take forward its commitment to implement the 2030 Agenda for Sustainable Development and the SDGs through its internal and external action policies. As part of the dialogue on annual programming as outlined in the Interinstitutional Agreement on Better Law-Making, the Commission is open to engage with the Council both before and after the adoption of its annual work programme on the implementation of the SDGs based on the annual SDG monitoring report published by Eurostat. The Commission will draw up its future work programmes in line with its institutional prerogatives.

With respect to multiannual programming, the Commission considers that it is essential to maintain an efficient and comprehensive procedure to implement the programming elements of the Interinstitutional Agreement on Better Law-Making. Therefore, the Commission will consider, if appropriate, the preparation of one report at the end of the legislative term in order to facilitate the discussions on multi-annual programming at the start of the next legislative term."
