- 2. In its proposal, the <u>Commission</u> suggests that the <u>Committee of the Regions</u> be consulted on an optional basis<sup>1</sup>.
- 3. Article 43(2) of the Treaty on the Functioning of the European Union, on which the proposal is based, does not require the opinion of the Committee of the Regions. Nevertheless, given the subject matter of the proposal, it would appear appropriate to consult that Committee.
- 4. The <u>Permanent Representatives Committee</u> is therefore invited to decide, in accordance with Article 307 of the Treaty on the Functioning of the European Union and Article 19(7)(h) of the Council's Rules of Procedure, to consult the Committee of the Regions on the above proposal and to request it to give its opinion as soon as possible.
