I. BACKGROUND

- 1. On 4 June 2025, the <u>Commission</u> submitted to the Council a proposal for a Council Implementing Decision extending temporary protection as introduced by Implementing Decision (EU) 2022/382, as set out in out in 9422/25 INIT.
- 2. The objective of the proposal is to extend the temporary protection given to persons displaced from Ukraine for a further period of one year until 4 March 2027. The temporary protection was initially activated on 4 March 2022 by Implementing Decision (EU) 2022/382 for an initial duration of one year and it was then automatically extended by another year until 4 March 2024. On 19 October 2023, the Council adopted Implementing Decision 2023/2409 to extend temporary protection for the period of one year until 4 March 2025 and on 25 June 2024, the Council adopted Implementing Decision 2024/1836 to extend it by another year until 4 March 2026.

- 3. The draft Council Implementing Decision is based on Article 4(2) of Council Directive 2001/55/EC of 20 July 2001 on minimum standards for giving temporary protection in the event of a mass influx of displaced persons, considering that the reasons for temporary protection persist.
- 4. The JHA Counsellors (Asylum) examined the proposal at its meetings on 5 and 6 June 2025 and broadly supported the text.
- 5. On 11 June 2025, the <u>Permanent Representatives Committee</u> prepared the Council discussion on this proposal.
- 6. On 13 June 2025, the <u>Council</u> reached a political agreement to extend the temporary protection for a further period of one year until 4 March 2027.

II. CONCLUSION

- 7. In view of the above, the <u>Permanent Representatives Committee</u> is now invited to confirm its agreement and to suggest that the <u>Council</u> at one of its forthcoming sessions adopts the Council Implementing Decision as set out in 10280/25 INIT (as finalised by the legal-linguistic experts).
- 8. The European Parliament will be notified of the Council Implementing Decision in accordance with Article 5(5) of Directive 2001/55/EC.
