Subject: Transfer of appropriations No DEC 09/2026 within Section III - Commission
- of the general budget for 2026

- *Approval of a letter*

1. On 26 May 2026, the Commission submitted to the Council proposal for transfer of appropriations No DEC 09/2026 related to the mobilisation of the European Globalisation Adjustment Fund at the initiative of the Commission (EGF/2026/000 TA 2026 - Technical assistance)¹, in accordance with Article 31(1) of the Financial Regulation².

2. As recorded in document 9736/26, the purpose of this proposal is to transfer an amount of EUR 210 000 in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) and an amount of EUR 210 000 in payment appropriations from Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 01 01 (*Support expenditure for the European Globalisation Adjustment Fund for Displaced Workers*).
3. The Budget Committee examined the proposal for a transfer at its meeting on 11 June 2026.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 9136/26; and
 - the draft letter in the ANNEX to this note.
