The Committee took note of the information provided by the Presidency on the outcome of the trilogue of 15 June 2016 and reached an agreement on the compromise text proposed by the Presidency.

Statement by CZ

"By this statement the Czech Republic expresses its disagreement with the article 23 of OCR, which sets out specific rules on official controls and other official activities for organic production and labelling of organic products. The Czech Republic fears the negative impact of this article on the transparency and integrity of controls in organic production.

Rules on organic production and their controls stand over the entire basic legislation. It is precisely and only the tight link between the rules on controls and the rules of production that provides the necessary level of credibility and transparency of the organic certification system. Breaking this link by a partial displacement of the rules into the OCR can negatively influence the consumers' perception of certified organic products. The consumers' confidence is undoubtedly a basic prerequisite for the development of the organic food market and therefore also for the development of the whole organic production sector.

The above mentioned concerns of the Czech Republic are based on the following estimated impacts of the concrete parts of the article 23 of the OCR proposal:

- 1) Concerning the letter b), including the link to the so called EU reference centres - respectively containing the tasks and responsibilities set within the EU reference centre for organic production controls. We lack more specific information regarding the impact of the inclusion of organic production into this system and especially we lack a specification of particular benefits that are supposed to arise from this institution to the organic production. Given the above mentioned arguments, we fear that this proposal will bring an unwarranted increase of the administrative burden for the relevant state administration bodies in Member States.

- 2) In the context of the letter c), which deals with the inclusion of the organic production into the system of administrative assistance, and consequently with the exchange of information among the Member States, it is not obvious how the coexistence with the current system of notifications of irregularities in organic production would be dealt with. Currently, the obligatory exchange of information between Member States by using notifications works through the Organic Farming Information System (OFIS). Any problems and irregularities found in organic products originating in different Member States or third countries are reported to the OFIS. All the duties and deadlines are anchored in the current regulation on organic production. However, only real and confirmed problems are reported to OFIS. According to the official statistics of the European Commission, more than 90% of the findings connected to breaking the organic production rules are the result of the presence of non-allowed substances in organic products. However, in 88% of the cases the cause of such contamination was not found, even though an investigation was conducted. These statistics also note that currently in more than 70% of these cases the Member States have not adopted any special measures to remedy this problem.

Hence the Czech Republic regrets the lack of any impact assessment of the inclusion of the organic production into the system of Administrative assistance – especially regarding the potential benefits of this inclusion. The current proposal states that even a probability of the occurrence of irregularities should be reported, which practically means that any suspicion should be reported. This measure will be a source of an increase of the Member States' administrative burden without any clear value added.

- 3) According to the letter d), methods of sampling, testing and laboratory analyses are supposed to be determined. The Czech Republic is of the view that sampling is an integral and absolutely logical part of the control process as such. Establishing rules for the actual performance of controls in one regulation and rules for sampling and testing in another regulation is not a provision leading to simplification and increased transparency."
