STATEMENT 56/00

Commission statement on the themes for studies (Annex IA and B)

"The Commission has taken careful note of the possible themes for studies on languages included in the amendments put down by the Parliament during its examination of the Commission's proposal on the European Year of Languages 2001. The Commission is conscious of the importance of language issues in the process of European integration and is committed to developing these themes in its programme of studies. That work will be undertaken within various relevant programmes and activities, in accordance with the procedures applying to them, in the spirit of Article 8 of the proposed Decision."

STATEMENT 57/00

COMMISSION AND COUNCIL STATEMENT

"The Commission and Council note that the negotiations on a wines and spirits agreement with South Africa have been concluded on 9 June 2000 at a technical level and will be submitted for approval to the Council as soon as possible.

They underline that this agreement, in particular its provisions on protection of intellectual property, together with the Trade, Cooperation and Development Agreement and the South Africa Development Programme, are regarded by them as a package and that progress on all three components is essential for the successful implementation of the package as a whole.

They also confirm that Annex 10 of the Trade, Cooperation and Development Agreement came into effect on 1 January 2000 on a provisional basis. This means that the start of the transition period for the phasing out of the port and sherry names began on the same date."

STATEMENT 58/00

COMMISSION STATEMENT

"The Commission states that the additional euro 35 million of resources to be allocated to action under the regulation on Development Cooperation with South Africa over the period 2000-2006 will be found exclusively from the allocations initially foreseen for the same period for food aid. The necessary transfer will therefore in no way affect the funding foreseen for other regional cooperation programmes financed through the Community budget."

STATEMENT 59/00

Council statement

Re Article 7:

"The Council notes that methods of supervising the operational risks of financial undertakings are not currently subject to Community legislation. It invites the Commission to examine the principles concerning the supervision of such risks, particularly those related to the outsourcing of activities, and to submit appropriate legislative proposals on this issue relating to all financial undertakings subject to prudential supervision."

STATEMENT 60/00

Statement by the Italian delegation

"With regard to the agricultural prices for sugar for the 2000-2001 marketing year, the Italian delegation states that its position on the regional price for sugar remains unchanged."

STATEMENT 61/00

Statement by the Spanish delegation

"The Spanish delegation regrets the fact that during the discussion on agricultural prices for the 2000-2001 marketing year there was still no response to the repeated request that the nut-growing sector receive support, failing which the sector will not be able to survive, given the international competition and inadequate external protection."

STATEMENT 62/00

Joint statement by the Council and the Commission

"The Council and the Commission agree that if the funds allocated at Community level do not make it possible to cover the planned maximum support levels for eligible expenditure by Member States, for both minimum and extended Community programmes, then the available funds should be allocated to those activities in the following way:

- priority should be given to data relating to the most significant fisheries in economic and social
 terms, taking account of the comparative biological vulnerability of the various stocks, and of
 the connection of each sort of data with the decisions to be taken under the common fisheries
 policy;
- a balance should be ensured, both geographically between the various fisheries, and between individual fields, particularly biology, fleet monitoring and economics."

STATEMENT 63/00

Statement by the Commission

"Since the procedure being established is not intended to increase Community appropriations for supporting the collection and management of data needed for the common fisheries policy, but to rationalise the aid granted, the Commission considers it to be crucial that Member States should maintain the sums allocated at national level for the collection and management of such data."

STATEMENT 64/00

Statement by the Commission

"When drawing up implementing Regulations, <u>the Commission</u> will take care that the groups of vessels referred to in Annex I are sufficiently homogeneous to allow a proper evaluation of the economic state of the fleets."

STATEMENT 65/00

Statement by the Commission

"The reference to the collection of annual data (Article 4(4)) does not imply that sampling programmes of the same intensity must be implemented every year. Procedures based on an intensive sampling programme during one year, followed by a less intensive collection in the following years to update initial estimates would be acceptable, as long as the precision of each annual estimate is quantified and sufficient."

STATEMENT 66/00

Statement by the Commission

"Taking into account the fact that the full implementation of the provisions on economic data has been postponed, the Commission nevertheless urges Member States to make all possible effort to collect these data in order to contribute to the review of the Common Fisheries Policy in 2002."

STATEMENT 67/00

Joint statement by the Council and Commission

- "The Commission indicates its willingness, in the framework of the report provided for in Article 10(2), to pay special attention to the collection of economic data related to the processing industry, including a cost/benefit analysis of such a collection.
- <u>The Council</u> invites the Commission to submit, if necessary, any appropriate proposal for amending the Regulation."

STATEMENT 68/00

Statement by the Commission

"The Commission notes the agreement of the European Parliament and the Council to provide for a regulatory procedure when considering the choice of projects, as opposed to the management procedure proposed by the Commission in the modified proposal following Parliament's second reading.

The Commission insists, as it stated at the time of the adoption of the common position, on the importance of applying the criteria of Article 2 of Council Decision 468/99/EC of 28 June 1999, laying down the procedures for the exercise of implementing powers conferred on the Commission.

The Commission believes that, the choice of projects being a measure with substantial budgetary implications, this should follow the management procedure.

The Commission considers that to ignore the terms of Article 2 of Council Decision 468/99/EC in a case as clear as this is contrary to both the spirit and the letter of the Council Decision.

The Commission must therefore reserve its position in this matter, including its right to take appropriate future action before the Court."

STATEMENT 69/00

Statement by the Council

"The Council notes the statement by the Commission regarding the choice of the committee procedure for the adoption, by the Commission, of implementing measures under the LIFE Regulation.

In choosing the regulatory procedure contained in Article 5 of Council Decision 468/99/EC of 28 June 1999, laying down the procedures for the exercise of implementing powers conferred on the Commission, the Council took into account the experience gained with the regulatory procedure under the LIFE instrument during the first (since 1992) and second phase (since 1996) and the nature of the LIFE instrument, which plays a vital role in the protection of the environment within the Community and contributes to the implementation and development of Community environmental policy.

The Council recalls that the criteria laid down in Article 2 of Council Decision 468/99/EC are legally non-binding and of an illustrative nature. The Council considers that the scope of the implementing powers in this Regulation fully justify having recourse to a regulatory procedure."

STATEMENT 70/00

Statement by the Commission

"The Commission states that before fixing annually the dates for the submission of proposals, it will check their feasibility with the relevant committees."

STATEMENT 71/00

Commission statement for the minutes

"The Commission undertakes to submit during the first months of 2000 the report concerning operations financed in the financial years 1997, 1998 and 1999, called for in Article 12 of Regulation (EC) No 443/97.

It further undertakes to submit proposals on a possible extension of that Regulation beyond 31 December 2000 on the basis of an overall assessment of operations decided on since 1997 and their implementation."
