Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003<sup>2</sup> on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) By its Decisions of 24 February 2022<sup>3</sup>, 12 July 2022<sup>4</sup>, 21 March 2023<sup>5</sup>, 29 March 2023<sup>6</sup> and 1 June 2023<sup>7</sup>, the Council appointed members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2025
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Jiří PUTNA.
- (3) The government of Czechia has nominated a candidate for the vacant seat,
