 On 16 October 2009 <u>the Commission</u> sent the Council the above proposal ¹, based on Article 61(c) and the second indent of Article 67(5) of the TEC. Following the entry into force of the Treaty of Lisbon, the proposal must be adopted on the basis of Article 81(2) of the TFEU ² ³.

- 2. <u>The European Economic and Social Committee</u> delivered its opinion on 14 July 2010¹.
- 3. In accordance with the provisions of the Joint Declaration on practical arrangements for the codecision procedure ², informal contacts were initiated between the Council, the European Parliament and the Commission with the aim of reaching agreement at first reading.
- 4. <u>The European Parliament</u> adopted its position at first reading on 13 March 2012, adopting one compromise amendment to the Commission proposal. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council ³.
- 5. The Permanent Representatives Committee is therefore asked to confirm its agreement and to suggest that the Council:
 - adopt the Regulation as set out in PE-CONS 14/12 as an "A" item at a forthcoming meeting, with the Maltese delegation voting against;
 - order the statement in <u>the Addendum</u> to this note to be entered in the minutes of that meeting.

After being signed by the President of the European Parliament and the President of the Council, the legislative act will be published in the Official Journal of the European Union.
