The SCA took note of the Commission's presentation of the above proposal, contained in 8368/15, as well as the comments of the delegations and the opinion of the Council Legal Service.

The SCA also took note of the qualified majority in favour of the text of the Regulation as proposed, with the addition of Article 114 TFEU to the legal basis, and authorised the Presidency to send a letter to the Chairman of COMAGRI in which the Council would undertake to adopt the text of the proposal with this amendment, provided that the European Parliament did the same.
