**STATEMENT BY DENMARK** concerning the Commission proposal on sprat

"Given the importance of the sprat fishery for Denmark, the Danish delegation has at an early stage following the publication of the ICES advice for sprat, and ahead of the adoption of the Commission proposal, consulted with the Commission on possible ways forward, in order to handle that ICES now gives a joint MSY advice for Skagerrak/Kattegat and the North Sea, to ensure a level playing field between the two sea basins. The ICES advice means a reduction of the fishing opportunities for sprat in the fishing year 2019/2020. While sprat in the North Sea is an EU-stock, sprat in Skagerrak/Kattegat is shared with Norway.

Despite new scientific information for two TAC-areas, the Commission in its proposal, unfortunately, decided to solely propose fishing opportunities for the North Sea whereby the fishermen in the North Sea take the full reduction of an advice covering two areas, while maintaining the fishing opportunities set for Skagerrak/Kattegat for the calendar year of 2019 stable. Such an approach goes against ensuring a level playing field for the fishermen in the two sea basins. Furthermore, the approach of the Commission deeply worries us, given its potential horizontal implications, as rather than defending the interests of EU fishermen, the Commission in this case has decided to let EU fishermen take the full reduction, while allowing third countries to maintain the level of their fishing opportunities. While we strongly support that fishing opportunities should be set in line with the best available scientific advice, the Commission approach for implementing the scientific advice is not reasonable. However, the Presidency compromise allows for flexibility from Skagerrak/Kattegat to the North Sea. Therefore, given the circumstances including the need for a swift solution Denmark agrees to the Presidency compromise as a short term solution.

Denmark expects that the Commission will cooperate to revise the fishing opportunities for both Skagerrak/Kattegat and the North Sea for 1<sup>st</sup> half of 2020, once EU and Norway have agreed on a sharing for the stock between the two sea basins."

### STATEMENT BY DENMARK, GERMANY AND SWEDEN concerning flexibility from 3a to the North Sea on sprat

"Denmark, Germany and Sweden welcome that agreement has been found to introduce full flexibility for sprat from 3a to the North Sea for Member States with quota on both sides. This full flexibility should only be included for the fishing year July 2019 to June 2020.

It has not yet been possible to reach agreement between EU/NO on a future sharing arrangement between 3a and 4, given the short time period between the advice release (12 April) and the start of the fishery (1 July).

On this basis it is necessary for the fishing year July 2019 to June 2020 to find an *ad hoc* agreement in line with the objectives of the CFP and ensuring a level playing field between the two sea basins.

As part of this *ad hoc* solution, flexibility is essential in ensuring that fishing opportunities are not lost

Denmark, Germany and Sweden encourage the Commission to – as soon as possible – arrange with Norway a working group to develop and recommend methods for the sharing of sprat between Skagerrak/Kattegat and the North Sea, preferably ahead of the consultations in the autumn. When such an agreement has been reached with Norway this autumn, any continued need for flexibility will be presented to Member States concerned."
