In preparation for the "Agriculture and Fisheries" Council on 21 September 2020, the SCA exchanged views on the implementation of the European Council conclusions on the Multiannual Financial Framework on the basis of the Presidency paper including drafting suggestions set out in document 10439/20.

The SCA took note of the Presidency briefing on the state of play on the new delivery model.

In addition, the SCA endorsed the Presidency's questions proposed in document WK 9329/2020 for the Council's policy debate on 21 September 2020 and took note of delegations' preliminary views on them.

The SCA also took note of the information from the Danish and the Netherlands delegations on targeted support for green ambition set out in document 10739/20, as well as of the Commission's and some delegations' views on it.

4. *Revised mandate for negotiations with the European Parliament*

The SCA noted there was a qualified majority of delegations who supported the Presidency suggestions. Therefore, the SCA gave the Presidency a revised negotiating mandate on the basis of the text set out in document 10607/20.

The SCA also agreed that the Council's revised negotiating mandate public could be made public after the next trilogue.

5. Organisation of future work

The Presidency informed delegations on the "Agriculture and Fisheries" Council on 21 September 2020. As regards that Council meeting:

- Information was given that an AOB on African swine fever will be included on the agenda, to be tabled through the Coreper channel.
- The French delegation expressed its intention to table an AOB item on protein imports for feed.
- The Czech delegation expressed its intention to table an AOB item on the pig meat market.
- The Czech and Italian delegations informed about their intention to table an AOB item, through the Coreper Channel, on nutrition labeling.

The Presidency also informed delegations about the next SCA meeting on 28 September 2020.
