EXPLANATORY MEMORANDUM

1. CONTEXT OF THE DELEGATED ACT

The Bulgarian, Czech, French, Greek, Hungarian, Latvian, Maltese and Slovenian language versions of Commission Delegated Regulation (EU) 2016/1149 contain errors. In order to align those language versions with the other language versions, a Delegated Regulation correcting Delegated Regulation (EU) 2016/1149 needs to be adopted.

2. LEGAL ELEMENTS OF THE DELEGATED ACT

This Delegated Regulation corrects translation errors in the Bulgarian, Czech, French, Greek, Hungarian, Latvian, Maltese and Slovenian language versions of the text.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing a common organisation of the markets in agricultural products and repealing Council Regulations (EEC) No 922/72, (EEC) No 234/79, (EC) No 1037/2001 and (EC) No 1234/2007¹, and in particular Article 53 thereof,

Having regard to Regulation (EU) No 1306/2013 of the European Parliament and of the Council of 17 December 2013 on the financing, management and monitoring of the common agricultural policy and repealing Council Regulations (EEC) No 352/78, (EC) No 165/94, (EC) No 2799/98, (EC) No 814/2000, (EC) No 1290/2005 and (EC) No 485/2008², and in particular Article 63(4) thereof,

Whereas:

- (1) The Bulgarian, Czech, French, Greek, Hungarian, Latvian, Maltese and Slovenian language versions of Commission Delegated Regulation (EU) 2016/1149³ contain errors in Article 53(2), first subparagraph, as regards minor changes to beneficiaries' operations and the eligibility of any part of the operation and its overall objectives.
- (2) The Bulgarian, Czech, French, Greek, Hungarian, Latvian, Maltese and Slovenian language versions of Delegated Regulation (EU) 2016/1149 should therefore be corrected accordingly. The other language versions are not affected,

HAS ADOPTED THIS REGULATION:

Article 1
