THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 31(2) thereof,

Having regard to Council Decision (CFSP) 2015/1333 of 31 July 2015 concerning restrictive measures in view of the situation in Libya, and repealing Decision 2011/137/CFSP<sup>1</sup>, and in particular Article 12(2) thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

#### Whereas:

- (1) On 31 July 2015 the Council adopted Decision (CFSP) 2015/1333.
- (2) Pursuant to Article 17(2) of Decision (CFSP) 2015/1333, the Council has reviewed the lists of designated persons and entities set out in Annexes II and IV to that Decision.
- (3) The Council considers that the entries for two persons and one entity should be deleted, and restrictive measures against all other persons and entities maintained, in the lists set out in Annexes II and IV to Decision (CFSP) 2015/1333. In addition, the identifying information for one person should be updated.
- (4) Decision (CFSP) 2015/1333 should therefore be amended accordingly,
