Dear Mr Secretary-General,

The purpose of this letter is to transmit the list of candidates for the replacement of one member of the Management Board of the European Food Safety Authority (EFSA), as approved by the Commission Decision C(2021) 5122 final on \$13.7.2021.

Article 25 of Regulation (BC) No 178/2002 of the European Parliament and of the Council of 28 January 2002 states that the Management Board shall be composed of 14 members appointed by the Council, in consultation with the European Parliament, from a list drawn up by the Commission.

Article 25 of the above-mentioned Regulation further provides detailed rules regarding the appointment of members of the Management Board:

- the list drawn up by the Commission shall include a number of candidates substantially higher than the number of members to be appointed;
- four of the members shall have their background in organisations representing consumers and other interests in the food chain;
- the members of the Board shall be appointed in such a way as to assure the highest standards of competence, a broad range of relevant expertise and, consistent with these, the broadest possible geographic distribution within the Union;
- members' term of office shall be four years, and may be renewed once.

The term of office of one member of the EFSA Management Board who was appointed by the Council in  $20\,18^{\rm i}$  expired on 30 June 2021. This member had a background in organisations representing consumers and other interests in the food chain.

On the basis of the provisions of Article 25 of Regulation (EC) No 178/2002, a call for expressions of interest was published in the Official Journal of the European Union<sup>ii</sup> on 7 April 2021. In accordance with the background of the outgoing member, the call included a mandatory requirement of background in organisations representing consumers and other interests in the food chain.

- Publication on DG SANTE and EFSA websites;
- Dissemination to the stakeholders within the Advisory Group on the Food Chain and Animal and Plant Health and Health Policy Forum;
- Dissemination through EFSA to its stakeholder engagement fora;
- Dissemination through DG ENV and DG JUST stakeholder engagement fora relating to biodiversity/chemicals domains and consumers respectively,
- Dissemination to all EU Permanent Representations of the Member States to the EU.
- Forwarded to the Council for further circulation amongst EU Member States' delegates.

A Selection Committee – chaired by Mr Delsaux, Deputy Director General (DG SANTE), and composed of Mr Dumitru, Deputy Director General (DG AGRI), Ms Schreiber, Director (DG GROW), Mr Sadauskas, Director (DG ENV) and Mr Bell, Director (DG RTD) – assessed the applications received by the Commission.

Of the nine applications received, two were declared eligible and those candidates were assessed on the basis of the criteria set up in the above-mentioned call, namely having a background in organisations representing consumers and other interests in the food chain. Having regard to the above-mentioned provisions laid down in Article 25 of Regulation (EC) No 178/2002 and to the comparative evaluation of the qualifications of those candidates, the Commission has selected the two persons listed in the Annex to this letter to form the list which the Commission is required to draw up.

Therefore, please find enclosed in the Annex the list of two candidates selected by the Commission. The relevant documentation concerning the applicants (completed application form and CV) will be transmitted by encrypted e-mail to relevant Council services (Directorate LIFE).

The Annex lists the candidates by alphabetical order. In this exercise, the list includes exclusively candidates having a background in organisations representing consumers and other interests in the food chain.

Finally, please note that in accordance with the provisions of Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies, the information transmitted herewith contains personal data and should be treated as confidential. # THE EUROPEAN COMMISSION.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 178/2002 of the European Parliament and of the Council of 28 January 2002 laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety<sup>1</sup>, and in particular Article 25 thereof,

#### Whereas:

- The Management Board is composed of 14 members appointed by the Council, in (1) consultation with the European Parliament, from a list drawn up by the Commission.
- The term of office of one member expires on 30 June 20212 and the vacant position (2)should be filled in.
- It is therefore necessary to appoint one new member of the Board. (3)
- The Commission has organised a selection procedure on the basis of the call for expression of interest<sup>3</sup> and in accordance with the provisions set out in Article 25 of (4) Regulation (EC) No 178/2002,

HAS DECIDED AS FOLLOWS:

## Sole Article

The alphabetical list of two candidates annexed hereto is adopted as the Commission list for submission to the Council and the European Parliament for the appointment of one member of the Management Board of the European Food Safety Authority.
