### INFORMATION NOTE

Subject: Decision of the Council on the approval of a draft design for the national side of the collectively issued 2 euro commemorative coin submitted by Finland

---

1. Pursuant to Article 10 of Council Regulation (EU) No 729/2014 of 24 June 2014 on denominations and technical specifications of euro coins intended for circulation<sup>1</sup>, and in accordance with Article 4(1)(a) and 4(3) of Regulation of the European Parliament and of the Council No 651/2012 of 4 July 2012<sup>2</sup>, and with Council implementing decision (EU) 2019/1263<sup>3</sup>, Finland submitted, through the General Secretariat of the Council, the draft design for:
  - the national side for a 2 euro commemorative coin with a common design, intended to be issued collectively in 2022 by the Member States whose currency is the euro, to mark the 35th anniversary of the Erasmus programme (as set out in document ST 10935/21).
2. In accordance with Article 10(4) of the Council Regulation, any Member State whose currency is the euro could, in a reasoned opinion addressed to the Council and to the Commission, raise an objection to the draft design proposed by the issuing Member State if that draft design was likely to create adverse reactions among its citizens. In accordance with

Article 10(5) of the Council Regulation, where the Commission considered that the draft design did not respect the technical requirements set out by the Council Regulation, it could submit a negative assessment to the Council.

3. No reasoned opinion or negative assessment had been submitted to the Council by 26 July 2021, which was the time limit set in accordance with Article 10(4) and (5) of the Council Regulation.
4. Therefore, pursuant to Article 10(6) of the Council Regulation, the decision approving the above-mentioned design is deemed to be adopted by the Council on 27 July 2021.<sup>4</sup>
5. It is recalled that, in accordance with Article 10(8) of the Council Regulation, all relevant information on new national circulation coin designs shall be published by the Commission in the *Official Journal of the European Union*.
6. The Permanent Representatives Committee/Council are invited to take note of this Information Note as an 'I/A' item on the agenda of their forthcoming meetings.
