# Summary report of the tenth meeting of the Executive Board

#### of the Conference on the Future of Europe

Tuesday 26 April 2022

17:00 to 18:00, Europa Building (room S3, hybrid meeting)

#### Summary and conclusions:

The Executive Board of the Conference on the Future of Europe held its tenth meeting on 26 April 2022 in hybrid format. The meeting was co-chaired by Member of the European Parliament, Guy VERHOFSTADT, French Secretary of State for EU Affairs, Clément BEAUNE, and Commission Vice-President for Democracy and Demography, Dubravka ŠUICA.

The Executive Board endorsed the agenda of the 29-30 April Conference Plenary.

The Executive Board received information on the preparation of the Plenary and the state of play on the proposals. An exchange of views among the members and observers followed with no changes to the text.

#### 1. Endorsement of the proposed agenda for the Plenary on 29-30 April 2022

Clément Beaune (Co-Chair) chaired this agenda point. He outlined the agenda for the Plenary on 29-30 April 2022 and proposed that the Executive Board should endorse it.

A representative of social partners asked for assurances that the representatives of the EU advisory bodies, elected representatives of regional and local authorities, social partners and civil society would also be given the floor during the Plenary.

Guy Verhofstadt (Co-Chair) confirmed that the different representatives would be able to intervene.

Clément Beaune (Co-Chair) concluded that the agenda of the Conference Plenary of 29-30 April was endorsed.

#### **Conclusion:**

The Executive Board endorsed the agenda of the 29-30 April Conference Plenary.

#### 2. Preparation of the Plenary on 29-30 April 2022

#### 2.1 Information by the Co-Chairs

Dubravka Šuica (Co-Chair) chaired this agenda point. She gave an overview of the detailed roll-out of the upcoming Plenary meeting.

#### 2.2 State of play on the proposals

Taken jointly with point 2.3 of the agenda.

#### 2.3 Exchange of views

Guy Verhofstadt (Co-Chair) chaired this agenda point. He gave an overview of the state of play on the proposals of the Plenary.

10969/22 MS/lt 2 GIP.COFE **EN**  The Executive Board exchanged views on the work on the proposals of the Working Group on 'European democracy'. The Chair of the Working Group informed about four pending points following the last Working Group meeting, i.e. a reference to civil society, including youth, a reference to the right of veto in the Council, a reference to voting from the age of 16, and a reference to the budgetary rights of the EP.

In the following exchange of views:

- A few speakers said that they did not have a mandate to express a position on the substance of the proposals in the Executive Board.
- Some participants considered that the text should remain as it was circulated by the Working Group Chair.
- Others insisted that on the outstanding points the comments received from the citizens in the Working Group should be taken as a basis.
- More generally, a number of speakers emphasised the importance that the citizens' input is the basis for proposals.
- One speaker took the view that the draft proposals on which the four components could not agree should not be included in the text.

The Executive Board did not make any changes to the text.

#### **Conclusion:**

The Executive Board received the information on the preparation of the Plenary and the state of play on the proposals. An exchange of views among the members and observers followed with no changes to the text.

Under any other business point, Dubravka Šuica (Co-Chair) pleaded towards involving the representatives of the Western Balkans in the final Plenary. Guy Verhofstadt agreed and (Co-Chair) proposed to discuss it among Co-Chairs after the meeting. One participant enquired about the future of the Digital Platform and favoured its continuation. Guy Verhofstadt (Co-Chair) informed that this was being currently examined.
