### Summary report of the eighth meeting of the Executive Board

#### of the Conference on the Future of Europe

Saturday 4 December 2021

11.00 - 12.00, Remote

#### Summary and conclusions:

The Executive Board of the Conference on the Future of Europe held its eighth meeting on 4 December 2021 in remote format. The Executive Board was called at short notice in reaction to the evolving epidemiological situation in Europe and its impact on upcoming Conference activities.

The meeting was co-chaired by Member of the European Parliament, Guy VERHOFSTADT, Slovenian State Secretary for EU Affairs, Gašper DOVŽAN, and Commission Vice-President for Democracy and Demography, Dubravka ŠUICA.

The Executive Board exchanged views on the third session of European Citizens' Panel 2 in Florence. The Executive Board endorsed the proposed decision to hold the Panel in Florence on the scheduled dates of 10-12 December, in full respect of the health measures in place, and in hybrid format.

The Executive Board decided to postpone this Conference Plenary meeting due to the evolving COVID-19 situation in several Member States, but to allow the Plenary Working Groups to organise their meetings in December remotely.

## 1. Endorsement of the proposed decision regarding the third session of European Citizens' Panel 2 in Florence

Gašper Dovžan (Co-Chair) opened the meeting, explaining that the Executive Board had been convened to discuss the implications of the Covid-19 situation for the upcoming European Citizens' Panel in Florence and for the third Conference Plenary in December. He stressed that health considerations needed to be an overarching concern and explained that the aim was to take a joint decision on whether to confirm these events in hybrid format or to postpone them.

Dubravka Šuica (Co-Chair) highlighted the rapidly changing epidemiological situation in Europe. She recalled that session 3 of the European Citizens' Panel 1, that was scheduled to take place in Dublin on 3-5 December, had to be postponed, notably on advice of the partner institute and the national authorities. She noted the different health situation in Italy compared to that in Dublin and that the partner institute advised that it is possible to proceed with the Panel in Florence in hybrid format, respecting all health and sanitary measures in place.

Guy Verhofstadt (Co-Chair) took the view that the Panel should go ahead, noting the positive assessment by the local authorities in Florence and the European University Institute hosting the Panel. He highlighted that the hybrid format would allow for remote participation for those participants who would not be able to travel to Florence and considered that postponements without a clear calendar would endanger the whole Conference.

In the following exchange of views:

- Many participants shared the view that the Panel should go ahead in hybrid format as proposed, taking into account the positive assessment by local authorities and partners and in compliance with the local health and sanitary measures.
- Some participants highlighted the importance to keep the momentum of the Conference and to proceed with the schedule as planned.

- Some participants raised concerns with the worsening health situation in different Member States.
- Some participants noted that remote participation does not allow for the same experience for citizens as the onsite one.

Gašper Dovžan (Co-Chair) concluded that the Executive Board endorsed the proposed decision to hold the third session of European Citizens' Panel 2 in Florence on the scheduled dates of 10-12 December, in full respect of the health measures in place, and in hybrid format.

#### **Conclusion:**

The Executive Board endorsed the proposed decision to hold the third session of European Citizens' Panel 2 in Florence on the scheduled dates of 10-12 December, in full respect of the health measures in place, and in hybrid format.

#### 2. Endorsement of the proposed agenda for the December Plenary

Following the decision to hold the third session of Panel 2 in Florence on 10-12 December, Guy Verhofstadt (Co-Chair) outlined the proposed agenda for the Conference Plenary on 17-18 December. He explained that the Plenary would take place in hybrid format and in full respect of the health and sanitary measures in France. He stressed the importance of Panel 2 presenting its recommendations to the Plenary just after their adoption and took the view that not having the Plenary would risk to undermine the dynamic of the Conference.

In the following exchange of views, members and observers of the Executive Board raised arguments either in favour to postpone the Plenary (Covid-19 situation, importance that two Panels per Plenary present their recommendations to avoid a narrow scope of discussions and creating imbalance between panels), or against (importance for the Conference to retain momentum and continue its work; dealing with the recommendations of one Panel would allow for more focussed and meaningful discussions). Some participants noted the different experience for those Members connecting remotely to the Plenary, taking the view that physical presence in Plenary is an important part of the exercise, in particular for citizens.

10979/22 MS/lt 3 GIP.COFE **EN**  After weighing all arguments, the Executive Board agreed to postpone the December Conference Plenary. In order to keep the momentum and allow the Conference to continue its work, the Plenary Working Groups could convene their meetings in December remotely.

#### **Conclusion:**

The Executive Board decided to postpone the Conference Plenary meeting of 17-18 December due to the evolving COVID-19 situation in several Member States, while allowing the Plenary Working Groups to organise their meetings in December remotely.
