<u>The Committee</u> examined four key issues on the basis of document 10610/08 and marked its agreement with the compromise suggestions from the Presidency contained therein. It took note of the progress achieved in the Working Party and instructed it to pursue its efforts to find solutions to still open issues as a matter of urgency. <u>The Committee</u> mandated the Presidency to meet with the Rapporteur of the European Parliament in an informal trialogue on 19 June 2008 with the aim to prepare the ground for an agreement at first reading.

<u>The Committee</u> decides to place the referral requested by <u>the French delegation</u> as a full point for discussion on the agenda of the Council. <u>The Italian delegation</u> reiterates its support of the referral.

<u>The Commission representative</u> makes a detailed presentation of the facts upon which, by 16 June and 23 June respectively, the Community quota of bluefin tuna had been deemed exhausted. <u>The French delegation</u> maintains its disagreement with the emergency measures.

<u>The Presidency</u> informed that at the informal trilogue held on 17 June 2008 an agreement had been reached on draft amendments concerning three proposals - common authorisation procedure, additives and enzymes. The content of this agreement, which was balanced and reflected well the Council position agreed by <u>the Committee</u> on 11 June 2008, had been sent to attachés on Foodstuffs (doc. 10892/08, 10893/08, 10890/08). <u>The Committee</u> agreed to proceed to the formal approval of draft amendments at its next session.

Concerning the fourth proposal (flavourings), <u>the Presidency</u> informed that another trilogue would be organized soon with a view to reach an agreement also on this file and allow for the whole package to be voted in the EP Plenary on 7 July 2008.
