- 24. Preparation of the Council meeting "Competitiveness" (Internal Market, Industry and Research) on 25 June 2007
  - Proposal for a Regulation of the European Parliament and of the Council laying down the Community Customs Code (Modernized Customs Code)

<u>The Committee</u> marked its approval of a Presidency compromise text (doc. 10911/07), and agreed to forward it to the Council (Competitiveness) for political agreement at its forthcoming session on 25 June 2007 as an item without discussion.

- 25. Proposal for a Council Regulation opening and providing for the management of autonomous Community tariff quotas for certain fishery products for the period 2007 to 2009
  - **Adoption** 10564/07 PECHE 189 10865/07 PECHE 205

The Committee examines the proposal and decides to:

- insert a recital in order to derogate from the six weeks period for national Parliaments given the urgency of the matter;
- reintroduce the 80 grammes size of herring per piece;
- introduce a gradual increase of the tariff quota for tuna loins for 2007-2009 (respectively 8000, 9000 and 10 000 tonnes);
- inscribe a joint statement by the Council and the Commission on ice-glazing in the minutes of Council and to publish this statement in the Official Journal of the European Union;

- inscribe the statement by the Commission on the monitoring of the market situation in the minutes of the Council, and to
- forward the proposal to Council for adoption under an "A" item procedure as soon as the text as finalised by the legal-linguistic service would be available.

# 26. Proposal for a Decision of the European Parliament and of the Council establishing a second programme of Community action in the field of health (2007-2013) (Second reading)

<u>The Committee</u> agreed to the compromise package elaborated during the informal trialogues as presented by the Presidency.

The Commission informed that it would make a unilateral declaration on the implementation of the budget of the health programme.

The Presidency concluded that a letter would be sent to the Chairman of the ENVI Committee informing that if, at its plenary in July 2007, the EP adopts the amendments to the common position and the trilateral declaration in the exact form as set out in the compromise package, the Council would do alike. This would permit the act in question to be deemed to have been adopted in the form of the common position thus amended.

<u>The Committee</u> reached agreement on a text on the basis of the Presidency compromise proposal set out in the Annex to 10738/07. This text will serve as a basis for an agreement with the European Parliament for the adoption of the proposed Directive at first reading. The Chair was mandated to inform the European Parliament accordingly.

The <u>French</u> and <u>Spanish</u> delegations were not in a position to support the agreed text.

While endorsing the agreed text in the name of an overall compromise, the <u>Polish</u> delegation pointed out that the obligation imposed on Member States to communicate to the Commission a correlation table should be interpreted as an exception to a long-established practice, consisting of transforming such an obligation to a mere encouragement in the recitals. According to the Polish delegation, such an exception should not be seen as setting a precedent.

# 28. Communication from the Commission on enhancing the patent system in Europe - Progress report 10710/07 PI 28 + REV 1 (en)

<u>The Committee</u> took note of the Presidency progress report, as contained in 10710/07 + REV 1(en) and agreed on the need to continue work towards finding solutions for an appropriate Community Patent system, as well as for a legally secure and cost effective patent litigation system.

<u>The Committee</u> took also note of the following joint statement by the <u>Italian and Spanish</u> <u>delegations</u>:

"The Italian and Spanish delegations wish to express their dissatisfaction regarding the Presidency's progress report, in particular on the following points:

- 1.- Despite the repeated request to translate into the other languages the Presidency questionnaire (8566/07) which forms the basis for discussion in the Working Party, the document was not translated, nor was any explanation given.
- 2.- Point 5 of the Presidency report does not properly reflect the position of the Member States which consider the political agreement of 2003 to be a valid basis for continuing negotiations, in particular as regards the language regime envisaged.
- 3.- Point 13 of the report, in which the Committee is invited to continue work, makes no reference to the principle of non-discrimination which is mentioned in Barcelona European Council conclusions and is as important as the other principles referred to or to the Commission Communication (8302/07) of 4 April 2007, which several delegations consider a good basis for continuing negotiations."

The <u>Chairman</u> indicated that discussion within the <u>Working Party on the Environment</u> on whether a new mandate was needed had been inconclusive. The <u>representative of the Commission</u> expressed the Commission's belief on the existence of community competence in the area and on the consequent need for a negotiating mandate from the Council.

The <u>Chairman</u> took note of the Commission's position but indicated that no new mandate could be approved, given the lack of qualified majority within the Committee.
