<u>The Committee</u> agreed that the EC and its Member States can support the adoption of the draft Standard if the following statement is made at the CAC:

"The EC welcomes the results of the work undergone by the Codex Alimentarius concerning the draft Standard for Gluten-Free Foods to address the particular nutritional requirements of people with coeliac disease.

The EC deems necessary to facilitate a consensus that would lead to the approval of a text. However taking into consideration the lacunas still existing in relation with the risk assessment, the EC invites the Commission of the Codex Alimentarius and the Member States to foster information campaigns in order to ensure the correct use of the products labelled as "gluten-reduced" by the coeliac patients.

Moreover the EC urges the scientific community to further develop the risk assessment relating to the oats food consumption by persons intolerant to gluten."

Information from the Presidency

The Committee was informed of the outcome of the meeting held in Strasbourg on 17 June 2008 between the Chair of the Committee and the EP rapporteur for the above proposal to discuss the way forward following the unexpected failure of the plenary vote on the jointly agreed first reading compromise text.

Given the rapporteur's assurances of a smoother passage for the text at second reading, the Committee agreed to ask the lawyer-linguists to begin preparing a Common Position on the basis of the same compromise text. Once finalised, the Common Position would then be forwarded to the Parliament before the end of the year, in expectation of a more successful outcome at second reading. The Committee further agreed to attach a statement to the text, prior to its final adoption, concerning the Council's views on the status of EP representatives to the ETF's Governing Board.
