6. Organisation of future work

The Presidency shared some suggestions regarding the streamlining of current work practices related to "any other business" items at "Agriculture and Fisheries" Council meetings.

The Presidency then informed the SCA about the SCA meeting on 18 July 2025 and the "Agriculture and Fisheries" Council meeting on 14 July 2025.

Regarding that Council meeting,

- The Commission requested a public item under "any other business", on the "Sixth African Union – European Union Agriculture Ministerial Conference" held in Rome on 27 June 2025; and
- Hungary requested a public item under "any other business", on the "Joint Declaration of the Ministers of Agriculture of the frontline Member States (Bulgaria, Hungary, Poland, Romania and Slovakia) on the agricultural aspects of the modification of the EU-Ukraine trade agreement".
- The SCA agreed that both the items requested by the Commission and Hungary would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
