## INTRODUZZJONI

Il-Kummissjoni, ta' kull sena, wara li teżamina mill-ġdid l-implimentazzjoni reali u l-užu mistenni tal-appropriazzjonijiet ta' pagament sa tmiem is-sena finanzjarja, tiproponi l-hekk imsejja "Trasferiment Globali" li huwa mfassal sabiex jerġa' jibbilanċja l-appropriazzjonijiet ta' pagament għas-sena baġitarja kurrenti. Sa fejn hu possibbli, in-nuqqas identifikat fl-appropriazzjonijiet jiġi indirizzat permezz ta' trasferimenti awtonomi tal-Kummissjoni fil-kapitoli rilevanti tal-baġit. Il-proposta għat-Trasferiment Globali tirrigwarda r-riāgġustamenti li ma jistgħux jiġi ssodisfati minn trasferimenti awtonomi ta' din ix-xorta.

It-Trasferiment Globali, bħal kull trasferiment ieħor, irid ikun newtru fl-effett baġitarju tiegħu. Il-ħtiġiġiet ta' pagament addizzjonal ta' certi programmi u azzjonijiet jistgħu jiġi indirizzati biss dment li jkun hemm rizorsi suffiċjenti minn sors oħra, fejn l-appropriazzjonijiet ikunu mistennija li jkunu sottoutilizzati sa tmiem is-sena.

Din is-sena, dawn ir-riallokazzjonijiet ma jistgħux jissodisfaw il-ħtiġiġiet kollha identifikati fil-previżjonijiet aġġornati tan-nefqa. Għalhekk, iż-żieda ta' EUR 1,5 biljun fl-appropriazzjonijiet ta' pagament se tiġi proposta fl-Abbozz ta' Baġit Emendarju Nru 10, biex jiġi żgurat li l-pretensionijiet pagabbli kollha jithallsu fl-2020 u li ma jibqa' l-ebda xogħol b'lura anormali għall-2021.

Il-proposta tat-Trasferiment Globali għall-2020 tirrigwarda l-appropriazzjonijiet ta' pagament li jammontaw għal EUR 595,4 miljun, li jikkorrispondu għal **0,39 %** tal-pagamenti totali awtorizzati fil-baġit tal-2020.

L-approprazzjonijiet ta' pagament li tqiegħdu għad-dispożizzjoni taħt xi intestatura ntużaw fl-ewwel lok biex jiġu koperti l-bżonnijiet f'dik l-intestatura stess, u biex jiġu evitati, sa fejn possibbli, penali finanzjarji fuq pagamenti tard. Meta approprazzjonijiet ta' pagament taħt intestatura kienu insuffiċjenti, id-disponibbiltajiet minn intestaturi oħra ntużaw biex ikopru l-ħtiġijiet pendentni.

## 2. Ir-rinforz u t-tnaqqis ta' approprazzjonijiet ta' pagament

Ir-rinforz u t-tnaqqis principali (aktar minn EUR 10 miljun) huma miġburin fil-qosor f'din it-taqSIMA.

### 2.1 Rinforz

It-talba għat-trasferiment tiproponi li jissaħħu 36 linja baġitarja. Il-linji ewlenin affettwati (jiġifieri li għalihom it-tibdil hu ogħla minn EUR 10 miljun) huma prezentati hawn taħt, skont l-intestatura u d-daqs dejem jonqos tar-rinforz:

#### 2.1.1 Intestatura 1a Il-Kompetittivitāt għat-Tkabbir u għall-Impieggi

- + EUR 33,8 miljun għal 06 02 01 05 - Il-ħolqien ta' ambjent li jiffacilita iktar l-investiment privat għal progetti għall-infrastruttura tat-trasport. Il-pagamenti għall-Instrument ta' Dejn tal-Faċilità Nikkollegaw l-Ewropa kien inizjalment previsti għas-sena 2021. Hekk kif il-progetti avvanzaw b'pass aktar mgħażżeġ milli mistenni, il-Bank Ewropew tal-Investiment digħi qed jitlob il-pagament finali ta' EUR 40,5 miljun fl-2020.
- + EUR 18,3-il miljun għal 14 02 01 - Appoġġ għall-funzjonament u l-modernizzazzjoni tal-unjoni doganali Kważi 80 % tan-nefqa hija marbuta ma' cikli twal ta' žvilupp u t-testjar tas-software tad-diversi sistemi tal-IT, li jagħmlu partikolarmen diffiċċi l-previżjonijiet preċiżi tal-approprazzjonijiet ta' pagament. Sa mill-bidu tal-2020, kien hemm żieda sinifikanti fl-għadd u fil-valur tal-fatturi għal din il-linjalba baġitarja. Ir-rinforz propost sejkopri l-ħtiġijiet addizzjonal li jirriżultaw minn dan il-livell ta' implementazzjoni li kien aktar għoli milli mistenni, u huwa ferm-importanti biex il-progetti tad-Dwana jkunu jistgħu jtitlestew: sa tmiem l-2020 se jiġu kkonsenjati 8 sistemi minn 17-il sistema gdida tal-IT meħtieġa għall-Kodiċi Doganali tal-Unjoni

## 2.1.2 Intestatura 2 Tkabbir Sostenibbli: Riżorsi Naturali

- + EUR 15-il miljun għal 07 02 01 - Kontribuzzjoni għal ekonomija ekoloġika u aktar effiċjenti fir-riżorsi u għall-iżvilupp u l-implimentazzjoni ta' politika u ta' leġiżlazzjoni ambientali tal-Unjoni. Il-Kummissjoni, sabiex twieġeb għall-križi tal-COVID-19 u tippermetti aktar likwiditā għall-benefiċjarji tal-programm LIFE tal-UE, iddeċidiet li żżid minn 30 % għal 40 % il-prefinanzjament tas-sejhiet għal proposti tal-programm LIFE kollha tal-2019 u tal-2020.
- + EUR 11-il miljun għal 07 02 02 - It-twaqqif u t-treġġigħ lura tat-telf tal-bijodiversità. Il-kummissjoni, sabiex twieġeb għall-križi tal-COVID-19 u tippermetti aktar likwiditā għall-benefiċjarji tal-programm LIFE tal-UE, iddeċidiet li żżid minn 30 % għal 40 % il-prefinanzjament tas-sejhiet għal proposti tal-programm LIFE kollha tal-2019 u tal-2020.

## 2.1.3 Intestatura 4 Ewropa Globali

- + EUR 100 miljun għal 22 02 03 02 - Sostenn għall-iżvilupp ekonomiku, soċjali u territorjali u għal allinjament progressiv relatat mal-acquis tal-Unjoni. Il-parti li jidfa tal-impenn għall-miżura specjalisti tal-2016 biex jiġu appoġġati r-refugjati fit-Turkija għandha titħallas lill-Fond Fiduċjarju Regionali tal-UE b'reazzjoni għall-križi Sirjana (EUTF Madad). Il-ħlas f'waqtu ta' din il-fattura huwa importanti fil-kuntest tal-frontloading tal-operazzjonijiet bħala parti mir-Rispons Globali għall-križi tal-COVID-19, kif imħabbar fil-bidu tas-sajf għall-aktivitajiet tal-Fond Fiduċjarju Madad. L-implimentazzjoni tal-pagamenti tal-EUTF Madad fl-2020 kienet ħafna ogħla milli kien mistenni fi żmien meta għie stabbilit I-Abbozz tal-Baġit tal-2020. Għalhekk, qed jintalab ir-rinforz ta' EUR 100 miljun fit-trasferment globali.

Barra minn hekk, hemm bżonn ta' appropriazzjonijiet ta' pagament addizzjonali taħt din il-linjal baġitarja minħabba r-riprogrammazzjoni, iż-żieda fil-pagamenti ta' prefinanzjament u l-mod ta' gestjoni indirett mal-pajjiż beneficijarju, biex jithaffu l-pagamenti biex tiġi indirizzata l-križi tal-COVID-19. Dan it-tiġi addizzjonali ta' EUR 90 miljun f'approprazzjonijiet ta' pagament se jintalab fl-Abbozz ta' Baġit Emendorju nru 10.

- + EUR 79 miljun għal 22 04 01 02 - Il-pajjiżi Mediterranji -- Tnaqqis tal-faqar u l-iżvilupp sostenibbli. Sabiex il-pajjiżi sħab jiġu megħejjuna jittrattaw il-konseguenzi ekonomiċi, soċjali u tas-saħħħa tal-križi tal-COVID-19, il-Kummissjoni qed timmodifika l-programmi li għaddejjin bħalissa sabiex thaffef l-implimentazzjoni tagħhom u l-pagamenti relatati. B'mod partikolari, diversi programmi ta' appoġġ baġitarju għall-Marokk, it-Tunezja, il-Ġordan u l-Algerija ġew miżjud u r-rekwiziti tagħhom għall-benefiċċju ta' intrapriżi żgħar u ta' daqs medju perezempju ġew miżjud, u l-pagamenti relatati żdied u thaffew.

Għalhekk, huwa meħtieg rinforz globali ta' EUR 325 miljun f'approprazzjonijiet ta' pagament, li minnhom EUR 25 miljun sejkun koperti permezz ta' trasferment awtonomu tal-Kummissjoni, EUR 79 miljun intalbu fit-trasferment Globali, u EUR 221 miljun se jintalbu fl-Abbozz ta' Baġit Emendorju nru 10.

- + EUR 72 miljun għal 22 04 02 02 - Sħubija tal-Lvant -- Tnaqqis tal-faqar u žvilupp sostenibbli. Sabiex il-pajjiżi sħab jiġu megħejjuna jittrattaw il-konseguenzi ekonomiċi, soċjali u tas-saħħħa tal-križi tal-COVID-19, il-Kummissjoni qed timmodifika l-programmi li għaddejjin bħalissa sabiex thaffef l-implimentazzjoni tagħhom u l-pagamenti relatati. B'mod partikolari, diversi programmi ta' appoġġ baġitarju għall-Armenja u l-Georgia ġew miżjud u r-rekwiziti tagħhom għall-benefiċċju ta' intrapriżi żgħar u ta' daqs medju u n-negozji (l-Armenja) ġew miżjud, u l-pagamenti relatati żdied u thaffew.

Għaldaqstant, huwa meħtieg rinforz ta' EUR 137 miljun, li minnhom EUR 72 miljun intalbu fit-trasferment Globali, u EUR 65 miljun se jintalbu fl-Abbozz ta' Baġit Emendorju nru 10.

- + EUR 38 miljun għal 22 04 02 01 - Is-Sħubija tal-Lvant -- Id-drittijiet tal-bniedem, il-governanza tajba u l-mobilità. Sabiex il-pajjiżi sħab jiġu megħejjuna jittrattaw il-konseguenzi ekonomiċi, soċjali u tas-saħħħa tal-križi tal-COVID-19, il-Kummissjoni qed timmodifika l-programmi li għaddejjin bħalissa sabiex thaffef l-implimentazzjoni tagħhom u l-pagamenti relatati. B'mod partikolari, diversi programmi ta' appoġġ baġitarju għall-Armenja ġew miżjud u r-rekwiziti tagħhom għall-benefiċċju ta' intrapriżi żgħar u ta' daqs medju u n-negozji (l-Armenja) ġew miżjud, u l-pagamenti relatati żdied u thaffew.

- + EUR 37 miljun għal 22 04 01 01 - Il-pajjiżi Mediterranean -- Id-drittijiet tal-bniedem, il-governanza tajba u l-mobilità. Sabiex il-pajjiżi sħab jiġu meħħjuna jittrattaw il-konseguenzi ekonomiċi, soċjali u tas-saħħha tal-kriżi tal-COVID-19, il-Kummissjoni qed timmodifika l-programmi li ghaddejjin bħalissa sabiex thaffef l-implementazzjoni tagħhom u l-pagamenti relatati. B'mod partikolari, ir-rekwiżiti għall-iżborż ta' porzjonijiet ta' appoġġ baġitarju ta' programm għall-Marokk ġew modifikati. Għalhekk, huwa meħtieġ rinforż ta' EUR 52 miljun f'approrjazzjonijiet ta' pagament, li minnhom EUR 15-il miljun se jkunu koperti permezz ta' trasferiment awtonomu tal-Kummissjoni, u EUR 37 miljun se jintalbu fit-trasferiment Globali.
- + EUR 35 miljun għal 19 02 01 - Rispons għall-kriżi u l-kriżiżiet emerġenti. L-implementazzjoni tal-Instrument li jikkontribwixxi għall-istabbiltà u l-paċi miexja 'l quddiem b'mod aktar mgħaqgħel milli kien stmat qabel. Abbaži tal-previżjoni riveduta, ir-rinforż propost huwa meħtieġ biex jitkomplew it-talbiet għall-ispejjeż u l-ewwel prefinanzjamenti dovuti fl-2020.
- + EUR 35 miljun għal 21 02 02 - Kooperazzjoni mal-Asja. In-nuqqas kumplessiv ta' apprōrjazzjonijiet ta' pagament f'din il-linjal baġitarja huwa stmat għal EUR 126,5 miljun. Hija prinċipalment marbuta mal-ħtieġa li jiġu antiċipati l-iżborżamenti tal-appoġġ baġitarju, normalment ippjanati għall-2021, sabiex ikun hemm rispons immedjat għall-pandemja tal-COVID-19. Il-pajjiżi affettwati huma n-Nepal, il-Myanmar u l-Kambodja.

Parti mill-ħtiġiġiet (EUR 41,5 miljun) se tkun koperta permezz ta' trasferiment awtonomu tal-Kummissjoni. Barra minn hekk, intalab l-ammont ta' EUR 35 miljun permezz tat-Trasferiment Globali, u se jintalab ir-rinforż ta' EUR 50 miljun fl-Abbozz tal-Baġit Emendorju nru 10 biex jitkoprew l-aktar pagamenti urġenti meħtieġa qabel tmiem l-2020.

- + EUR 24 miljun għal 22 04 03 01 - Kooperazzjoni transfruntiera (CBC) -- Kontribuzzjoni mill-Intestatura 4 Meta kienet qed thejji l-baġit, il-Kummissjoni għamlet stima prudenti tal-ħtiġiġiet għal apprōrjazzjonijiet ta' pagament f'din il-linjal baġitarja, fid-dawl tal-implementazzjoni tas-snin preċedenti u tal-esperjenza marbuta mal-preċiżjoni tal-previżjoniżiet tal-Istati Membri. Madankollu, l-implementazzjoni tal-proġetti qabdet ir-ritmu fl-2020 u l-Awtoritatiet ta' Ĝestjoni tal-baġit l-ammont sħiħ tal-prefinanzjament dovut fl-2020.
- + EUR 20 miljun għal 21 02 04 - Kooperazzjoni mal-Lvant Nofsani. In-nuqqas ta' apprōrjazzjonijiet ta' pagament f'din il-linjal baġitarja huwa prinċipalment marbuta mal-ħtieġa li jiġu antiċipati l-iżborżamenti tal-appoġġ baġitarju, normalment ippjanati għas-snin ta' wara, sabiex ikun hemm rispons immedjat għall-pandemja tal-COVID-19 fil-Jemen. Ir-rinforż huwa mitlub biex ikopri l-aktar pagamenti urġenti meħtieġa qabel tmiem l-2020.

## 2.2 Tnaqqis

It-talba għat-trasferiment tiproponi li jitnaqqas il-livell tal-apprōrjazzjonijiet ta' pagament għal **65 linjal baġitarja**. Il-linji ewleni affettwati (jiġifieri li għalihom il-bidliet huma aktar minn EUR 10 miljun), huma prezentati hawn taħt, skont l-intestatura u d-daqs dejjem jonqos tat-tnaqqis:

### 2.2.1 Intestatura 1a Il-kompetittività għat-tkabbir u l-impiegħi

- - EUR 52 miljun għal 32 04 03 01 - It-tranżizzjoni għal sistema enerġetika affidabbli, sostenibbli u kompetittiva. Minħabba l-kriżi tal-COVID-19, il-progress ta' diversi proġetti dam aktar milli mistenni u dan wassal għal posponiment fit-talbiet għall-pagamenti interim. Barra minn hekk, l-iffirmar tal-ftehimiet ta' għotja ddewwem ukoll, u dan wassal għal posponiment fit-talbiet għall-prefinanzjament.
- - EUR 50,2 miljun għal 08 02 01 01 - Tishħiħ tar-riċerka esploratorja fil-Kunsill Ewropew tar-Riċerka Id-detenturi tal-ġhotjet tal-Kunsill Ewropew tar-Riċerka fil-biċċa l-kbira huma monobenefiċjarji. Għalhekk, il-kwistjonijiet iffaċċjati mill-benefiċjarji minħabba l-kriżi tal-COVID-19 (id-dewmien fl-implementazzjoni tal-proġett) ma setgħux jiġu kkumpensati minn beneficijarji oħra li kienu inqas affettwati mill-krizi, kif jista' jkun il-każ għall-ġhotjet b'diversi beneficijarji f'linjal baġitarji oħra.

- EUR 31,6 miljun għal 08 03 01 01 - Euratom -- Energija mill-fużjoni. Is-surplus huwa dovut għal dewmien fl-implementazzjoni tal-kuntratt għall-operat tal-faċilitajiet tal-Joint European Torus (JET) mill-Awtorità tal-Enerġija Atomika tar-Renju Unit. Billi l-istadji importanti previsti fil-kuntratt ma ntlaħqu fl-2019, il-Kummissjoni Ewropea ddecidiet li tissospendi l-implementazzjoni tal-kuntratt, skont id-dispozizzjoni tal-kuntratt. Is-sospensjoni bdiet tapplika mill-1/01/2020 'il-quddiem, u issa huwa mistenni li l-kuntratt jkompli fl-1 ta' Ottubru 2020. L-emenda fil-kuntratt li tneħħi s-sospensjoni tinkludi estensjoni fit-tul ta' żmien kif ukoll bidliet operattivi.
- EUR 27 miljun għal 32 02 52 - It-tlestja ta' progetti tal-enerġija biex jiġi megħejun l-irkupru ekonomiku. Minħabba l-kriżi tal-COVID-19, il-progress fl-implementazzjoni tal-aħħar progetti huwa aktar kajman milli mistenni, u b'hekk is-sottomissjoni ta' talbiet għall-pagament qed iddum.
- EUR 26,8 miljun għal 08 02 03 01 - Titjib fis-saħħha u l-benesseri tul il-ħajja. Is-surplus huwa dovut għal talba għall-pagament aktar baxxa milli mistenni mis-Sħubja għall-Provi Kliniċi bejn Pajjiżi Ewropej u Pajjiżi li qed Jiżviluppaw (EDCTP), sħubja pubblika-privata appoġġata permezz ta' Orizzont 2020 biex tiġi žviluppata l-kapaċċità tar-riċerka klinika fl-Afrika sub-Saħarjana. Kien hemm dewmien fit-tħejja u l-implementazzjoni tal-għotjet, princiċialment minħabba l-pandemja tal-COVID-19 (pereżempju dewmien fil-wasla tad-dokumenti meħtieġa).
- EUR 23,6 miljun għal 32 03 04 02 - Il-programm Bohunice. Kienet antiċipata l-implementazzjoni mħaffa tal-programmi ta' dekummissjonar, madankollu minħabba l-kriżi tal-COVID-19 din ma seħħitx. Dan affettwa t-twassil fiżiku ta' materjal u l-preżenza ta' esperti barranin fuq il-post. Dan dewwem ukoll il-prefinanzjamenti mħallsa mill-Euratom fir-rigward ta' proċeduri ta' akkwist li ġew estiżi, li damu jew ġew sospizi biex itaffu r-restrizzjonijiet tal-operaturi ekonomiċi u tal-awtoritajiet nazzjonali.
- EUR 22,7 miljun għal 02 04 02 01 - Rwl ta' tmexxija fl-ispazju. L-implementazzjoni tal-akkwisti għall-kuntratti ta' Orizzont 2020 kienet aktar kajmana milli mistenni. Hafna akkwisti importanti kellhom jiġu posposti minħabba l-Brexit fid-dawl tal-evalwazzjoni dwar il-parteċipazzjoni tar-Renju Unit f'kuntratti sensitivi relatati mas-sigurtà.
- EUR 20,7 miljun għal 02 07 01 - Programm Ewropew għall-İżvilupp fl-Industrija tad-Difiża (EDIDP). Wara dewmien fit-tlep̄i tal-valutazzjoni tal-pilastri tal-“Organisation Conjointe de Coopération en matière d'Armement” (OCCAr), il-parti l-kbira tal-pagamenti trid tiġi posposta sakemm l-OCCAr tiġi vvalutata li hija komplettament konformi mal-pilastru (2021).

Parti mill-posponiment ġie kkumpensat minn prefinanzjament ieħor għas-sejħiet kompetitivi għal proposti sabiex tiġi appoġġata l-industrija tad-difiża fil-kuntest ekonomiku attwali. F'din is-sitwazzjoni, il-pagamenti totali għall-2020 jenħtieg li jkunu limitati għal EUR 179 miljun u s-surplus jista' jkun disponibbli.

- EUR 20 miljun għal 08 03 01 02 - Euratom -- Fissjoni nukleari u ħarsien mir-radjazzjoni. Il-Bank Ewropew tal-Investiment (BEI), bħala entità fdata mill-implementazzjoni tal-strument finanzjarju InnovFin, irrapporta li l-ebda waħda mill-operazzjonijiet relatati mal-qasam InnovFin iddedikat għall-Euratom ma hija se tkun matura bieżżejjed biex tiġi approvata mill-Bord tad-Diretturi tal-BEI sa Diċembru 2020. Għalhekk, l-appropjazzjonijiet li jikkorrispondu għall-qasam InnovFin iddedikat għall-Euratom mhux se jiġu implementati din is-sena u jistgħu jkunu disponibbli.
- EUR 18,5-il miljun għal 32 02 01 01 - Aktar integrazzjoni tas-suq intern tal-enerġija u tal-interoperabbiltà bejn in-networks tal-elettriku u tal-gass bejn il-fruntieri. ## **Justifications**

### **Decreased 01 03 02**

#### **Macro-financial assistance**

The expected third tranche of the disbursement of Macro-financial assistance for Moldova was definitively cancelled, with no possibility of postponement. Therefore, payments for grants will only amount to EUR 15,7 million in 2020, and an amount of EUR 11,3 million in payment appropriations can be made available.

### **Decreased 01 04 06**

#### **European Investment Advisory Hub (EIAH) and European Investment Project Portal (EIPP)**

Due to the current Covid-19 circumstances and uncertainty in the European market, the European Investment Bank will not request the expected second subsequent pre-financing in 2020 but will report this request to next year.

The total European Investment Advisory Hub can therefore make available an amount of EUR 2,5 million in payments appropriations.

### **Decreased 02 04 02 01**

#### **Leadership in space**

The implementation of the procurement of Horizon 2020 contracts has been slower than expected. Many important procurements had to be delayed due to Brexit in view of the evaluation on the participation of the UK to sensitive security related contracts. Therefore, an amount of EUR 22,7 million can be made available.

### **Decreased 02 04 77 06**

#### **Pilot project -- Space traffic management**

The final pre-financing rate (30%) in the procurement of this pilot project is lower than the original pre-financing established (50%). Therefore, an amount of EUR 140 000 can be made available.

### **Decreased 02 04 77 07**

#### **Preparatory action -- Preparing the new EU GOVSATCOM programme**

The delay in the signature of the contracts related to Govsatcom activities has resulted in a lower level of payment appropriations needed in 2020. The related contracts are expected to be signed by the end of this year and first pre-financings will take place in 2021. Therefore, an amount of EUR 3,2 million can be made available.

### **Decreased 02 04 77 08**

#### **Pilot project -- Aviation resilience to GNSS jamming and cyber-threats**

The pre-financing of this pilot project originally foreseen in 2020 will take place in 2021. Therefore, an amount of EUR 375 000 in payment appropriations can be made available.

### **Decreased 02 07 01**

#### **European Defence Industrial Development Programme (EDIDP)**

Following the delay in the finalisation of the pillar assessment of the "Organisation Conjointe de Coopération en matière d'Armement" (OCCAr) a large part of the payments has to be postponed until OCCAr is assessed to be fully pillar compliant (2021).

Part of the postponement has been compensated by further pre-financing of the competitive calls for proposals in order to support the defence industry in the current economic context. In this situation, the total payments for 2020 should be limited to EUR 179 million and an amount of EUR 20,7 million can be made available.

## **Decreased 04 04 01**

### **EGF -- to support workers and self-employed persons whose activity has ceased as a result of globalisation**

The assigned revenues available on this budget line are sufficient to cover the payment needs until the end of 2020 as there is only one case for the European Globalisation Adjustment Fund in the pipeline (EGF/2020/001 ES/Galicia shipbuilding ancillary sectors). Therefore, an amount of EUR 9,7 million in payment appropriations can be made available.

## **Decreased 05 05 03 02**

### **Support for economic, social and territorial development and related progressive alignment with the Union acquis**

Due to a reduced payment forecast for the third quarter of 2020, and the availability of assigned revenue (not known at the time of the establishment of the 2020 budget), an amount of EUR 15 million can be made available.

## **Decreased 05 05 04 02**

### **Support for economic, social and territorial development and related progressive alignment with the Union acquis**

Due to a reduced payment forecast for the third quarter of 2020, and the availability of assigned revenue (not known at the time of the establishment of the 2020 budget), an amount of EUR 50 million can be made available.

## **Decreased 05 06 01**

### **International agricultural agreements**

The EU contributions paid to the International Sugar Organisation, the International Grains Council and the International Olive Council were lower than estimated in the 2020 budget. Moreover, it will not be possible to use the amount of EUR 1 million budgeted in 2020 for the World Intellectual Property Organisation, as the Commission proposal to fix special contributions from members (including the EU) to cover the deficit of the Lisbon Union, has now become obsolete. An amount of EUR 1,6 million in payment appropriations can therefore be made available.

## **Decreased 05 09 03 01**

### **Securing sufficient supplies of safe and high quality food and other bio-based products**

An amount of EUR 10,4 million can be made available following beneficiaries requests to extend projects' duration due to the Covid-19 outbreak, and the resulting postponement of payment deadlines and final payments.

## **Increased 06 02 01 03**

### **Optimising the integration and interconnection of transport modes and enhancing interoperability**

The latest revision of the payment forecast for the Connecting Europe Facility support actions shows an additional need of EUR 1 million in payment appropriations.

## **Increased 06 02 01 05**

### **Creating an environment more conducive to private investment for transport infrastructure projects**

The payments for the Connecting Europe Facility Debt instrument were initially forecast for the year 2021. As the projects advanced at a faster pace than expected, the European Investment Bank is requesting the final payment of EUR 40,5 million already in 2020. Therefore, a reinforcement of EUR 33,8 million is needed.

## **Decreased 06 02 03 01**

### **European Maritime Safety Agency**

An amount of EUR 1 million in payment appropriations can be made available following the reprogramming of activities that could not take place due to the Covid-19 pandemic.

The funds mainly relate to the expenditures for Cooperation on Coast Guard Functions. The other affected expenditure includes Information Services & Databases, Communication, Workshops & Training, and Studies in support of the Agency's operations and Operational missions.

## **Decreased 06 02 03 02**

### **European Maritime Safety Agency -- Anti-pollution measures**

An amount of EUR 0,6 million in payment appropriations can be made available due to a number of activities that could not take place following travel restrictions.

## **Increased 06 03 03 01**

### **Achieving a resource-efficient, environmentally-friendly, safe and seamless European transport system**

Based on the revised estimates, a reinforcement of EUR 2,7 million is needed to cover the invoices to be received by the end of the year.

## **Increased 07 02 01**

### **Contributing to a greener and more resource-efficient economy and to the development and implementation of Union environmental policy and legislation**

In order to respond to the Covid-19 crisis and allow more liquidity for the beneficiaries of the EU LIFE programme, the Commission has decided to increase from 30% to 40% the pre-financing of all 2019 and 2020 LIFE calls for proposals. Therefore, a reinforcement of EUR 15 million in payment appropriations is needed in 2020.

## **Increased 07 02 02**

### **Halting and reversing biodiversity loss**

In order to respond to the Covid-19 crisis and allow more liquidity for the beneficiaries of the EU LIFE programme, the Commission has decided to increase from 30% to 40% the pre-financing of all 2019 and 2020 LIFE calls for proposals. Therefore, a reinforcement of EUR 11 million is needed in 2020.

## **Decreased 07 02 04**

### **Contribution to multilateral and international environment agreements**

After the payment of all the outstanding invoices, there is a surplus of EUR 0,2 million on the budget line, corresponding to a reserve for exchange rate fluctuations.

## **Decreased 08 02 01 01**

### **Strengthening frontier research in the European Research Council**

The European Research Council grant holders are mostly mono-beneficiaries. Therefore, issues faced by the beneficiaries due to the Covid-19 crisis (delays of project implementation) could not be compensated by other beneficiaries, less affected by the crisis, as it can be the case for multi-beneficiary grants on other budget lines. Hence, an amount of EUR 50,2 million can be made available.

## **Decreased 08 02 03 01**

### **Improving lifelong health and well-being**

The amount of EUR 26,8 million can be made available due to a lower than expected payment request from the European and Developing Countries Clinical Trials Partnership (EDCTP), a public-private partnership supported by Horizon 2020 to develop the clinical research capacity in sub-Saharan Africa. Mainly due to the Covid-19 pandemic, delays have occurred in grant preparation and implementation (for example, delays in receiving necessary documents).

## **Decreased 08 03 01 01**

### **Euratom -- Fusion energy**

An amount of EUR 31,6 million in payment appropriations can be made available due to delays in the implementation of the contract for the operation of the Joint European Torus (JET) facilities by the UK Atomic Energy Authority. As milestones foreseen in the contract were not achieved in 2019, the European Commission has decided to suspend the contract's implementation, in accordance with the contract provision. The suspension applied from 1st January 2020 onwards and it is now expected that the contract will resume on the 1st October 2020. The amendment to the contract lifting the suspension includes an extension of duration as well as operational changes.

## **Decreased 08 03 01 02**

### **Euratom -- Nuclear fission and radiation protection**

The European Investment Bank (EIB), as entrusted entity for the implementation of the InnovFin financial instrument, reported that none of the operations related to the InnovFin window dedicated to Euratom will be mature enough to obtain an approval from the EIB Board of Directors by December 2020. Therefore, the appropriations corresponding to the InnovFin window dedicated to Euratom will not be implemented this year and the amount of EUR 20 million can be made available.

## **Decreased 08 05 77 01**

### **Pilot project -- Research into reducing CO2 emissions in steel production**

Upon consortium request, the starting date of the pilot project has been postponed from December 2019 to January 2020. Consequently, payments initially foreseen in 2020 have to be postponed to 2021, and an amount of EUR 0,5 million can be made available.

## **Decreased 09 02 77 12**

### **Pilot project -- EU-wide programming contest**

Due to the Covid-19 pandemic, most of the EU code hackathons/workshops have been postponed to 2021. One interim payment will be paid in 2020 to cover the work prior to the suspension of the workshops. Therefore, an amount of EUR 235 580 in payment appropriations can be made available.

## **Decreased 09 02 77 13**

### **Pilot project -- EU grants for small-scale online media: supporting high-quality news products and tackling fake news**

The call for proposal for this project is still to be launched. The award decision will be finalised end of 2020/beginning 2021 with the project due to start in the first quarter of 2021. Therefore, no payments will be made in 2020 and an amount of EUR 550 000 in payment appropriations can be made available.

## **Decreased 09 02 77 14**

### **Pilot project -- Integrity of social media**

The call for proposal for this project is still to be launched. The award decision will be finalised end of 2020/beginning 2021 with the project due to start in the first quarter of 2021. Therefore, no payments will be made in 2020 and an amount of EUR 225 000 in payment appropriations can be made available.

## **Decreased 09 02 77 15**

### **Pilot project -- Smart urban mobility involving autonomous vehicles**

The call for proposal for this project ends 18/9/2020. The award decision will be finalised by the end of 2020 with the project due to start in the first quarter of 2021. Therefore there will be no payments in 2020 and an amount of EUR 250 000 can be made available.

## **Decreased 09 02 77 16**

### **Pilot project -- Media ownership monitor**

The call for proposal for this project is still to be launched. The award decision will be finalised end of 2020/beginning 2021 with the project due to start in the first quarter of 2021. Therefore no payments will be made in 2020 and an amount of EUR 250 000 in payment appropriations can be made available.

## **Decreased 09 02 77 17**

### **Preparatory action -- Media councils in the digital age**

No payments are expected in 2020 for this preparatory action. Therefore, an amount of EUR 125 000 in payment appropriations can be made available.

## **Decreased 09 05 77 08**

### **Preparatory action -- Cinemas as innovation hubs for local communities**

The Grant Agreements for this preparatory action were signed and the projects launched at the beginning of the second quarter of 2020. All pre-financing of 60% has been paid. Therefore, an amount of EUR 1 664 can be made available.

## **Decreased 09 05 77 10**

### **Pilot project -- Supporting investigative journalism and media freedom in the EU**

The Grant Agreements for this pilot project were signed and the projects launched in the second and third quarter of 2020. All pre-financing has been paid and the forecasted interim payments have been delayed to the first quarter of 2021. Therefore, an amount of EUR 335 054 in payment appropriations can be made available.

## **Decreased 10 02 77 03**

### **Pilot project -- Implementation of the research methodology `Multidimensional Inequality Framework` research methodology for the European Union**

Due to the Covid-19 crisis, workshops could not take place as planned or have been held as digital meetings, which led to lower expenses. Besides, the payments related to some IT expenses will only take place in 2021. Therefore, an amount of EUR 0,4 million in payment appropriations can be made available.

## **Decreased 10 02 77 04**

### **Pilot project -- Integrated techniques for the seismic strengthening and energy efficiency of existing buildings**

Due to the Covid-19 crisis, workshops could not take place as planned or have been held as digital meetings, which led to lower expenses. Therefore, an amount of EUR 147 000 can be made available.

## **Decreased 10 03 01**

### **Euratom activities of direct research**

Due to the Covid-19 crisis, the execution of contracts has slowed down for some months and the situation is still not back to normal. As this budget is implemented mainly through procurement and payments on deliverables, it is not expected that the delays can be recovered by year-end. Therefore, an amount of EUR 2 million in payment appropriations can be made available.

## **Decreased 10 05 01**

### **Decommissioning of Euratom obsolete nuclear facilities and final disposal of wastes**

An amount of EUR 3,9 million in payment appropriations can be made available, for the following reasons:

- Delays in the construction of the German national repository KONRAD in Karlsruhe. The costs for the construction and operation actually incurred were significantly lower than the forecast. This difference had been partially anticipated, but actual underspending due to this lower invoice amounts to EUR 1,9 million;
- A new grouting station dedicated to production of conditioned final waste packages is under construction in Ispra. The conditioning of solid radioactive waste in specific type of containers shall be done by embedding the radioactive waste in cement mortar. Delays in the contract execution has been worsened by the lock down, which is still limiting actual physical work on-site. Payments are linked to pre-defined deliverables for the construction and therefore could not be implemented. In addition, maintenance operations for the Nuclear Decommissioning facilities were reduced to the minimum necessary during the lock down. These delays led to a surplus of EUR 2 million in payment appropriations.

## **Increased 12 02 01**

### **Implementation and development of the single market for financial services**

A reinforcement of EUR 98 420 in payment appropriations is needed due to a higher amount of payments due on outstanding commitments. This is a consequence of an increase of the commitment appropriations in previous years.

## **Increased 14 02 01**

### **Supporting the functioning and modernisation of the customs union**

Nearly 80% of the expenditure is linked to lengthy software development and testing cycles of the various IT systems, which make precise forecasts of payment appropriations particularly difficult. Since the start of 2020, there has been a significant increase in number and value of invoices for this budget line.

A reinforcement of EUR 18,3 million in payment appropriations is requested to cover the additional needs stemming from this higher than expected level of implementation and is paramount to allow finalising the Customs projects: 8 out of the 17 new IT systems required for the Union Customs Code will be delivered by end 2020.

## **Decreased 14 02 02**

### **Membership of international organisations in the field of customs**

Following the decision of the Council of the World Customs Organization (WCO) in June, the 2020 contribution to the WCO was not adjusted compared to last year's contribution. Hence, the amount of EUR 13 056 can be made available.

## **Increased 14 03 01**

### **Improving the proper functioning of the taxation systems**

Since the start of 2020, there has been a significant increase in number and value of invoices for this budget line. A reinforcement of EUR 3,5 million in payment appropriations is requested to cover the additional needs stemming from this higher than expected level of implementation.

## **Increased 14 04 01**

### **Implementation and development of the internal market**

Since the start of 2020, there has been a significant increase in number and value of invoices for this budget line. Therefore, a reinforcement of EUR 0,5 million is requested to cover additional needs stemming from this higher than expected level of implementation.

## **Decreased 16 03 01 02**

### **Information for the media and audiovisual productions**

Due to the exceptional situation linked to the Covid-19 pandemic, many activities initially foreseen for 2020 have been cancelled or postponed. Accordingly, the payments expected in 2020 are lower than initially foreseen and an amount of EUR 1,5 million payment appropriations can be made available.

## **Decreased 16 03 01 03**

### **Information outlets**

Due to the exceptional situation linked to the Covid-19 pandemic, many activities initially foreseen for 2020 have been cancelled or postponed. Accordingly, the payments expected in 2020 are lower than initially foreseen and an amount of EUR 1 million in payment appropriations can be made available.

## **Decreased 16 03 01 04**

### **Communication of the Commission Representations, Citizens-- Dialogues and `Partnership` actions**

Due to the exceptional situation linked to the Covid-19 pandemic, many activities initially foreseen for 2020 have been cancelled or postponed. Accordingly, the payments expected in 2020 are lower than initially foreseen. This budget line is particularly affected as many information events to citizens organized by Representations and Citizens' Dialogues have been cancelled in 2020. Therefore, an amount of EUR 7,5 million in payment appropriations can be made available.

## **Decreased 16 03 02 02**

### **Operation of radio and television studios and audiovisual equipment**

Due to the exceptional situation linked to the Covid-19 pandemic, many activities initially foreseen for 2020 have been cancelled or postponed. Accordingly, the payments expected in 2020 are lower than initially foreseen and an amount of EUR 0,9 million can be made available.

## **Decreased 16 03 02 03**

### **Online and written information and communication tools**

Due to the exceptional situation linked to the Covid-19 pandemic, many activities initially foreseen for 2020 have been cancelled or postponed. Accordingly, the payments expected in 2020 are lower than initially foreseen and an amount of EUR 1 million in payment appropriations can be made available.

## **Decreased 16 03 02 05**

### **Public opinion analysis**

Due to the exceptional situation linked to the Covid-19 pandemic, many activities initially foreseen for 2020 have been cancelled or postponed. Accordingly, the payments expected in 2020 are lower than initially foreseen and an amount of EUR 2,1 million in payment appropriations can be made available.

## **Decreased 18 04 01 01**

### **Europe for citizens -- Strengthening remembrance and enhancing capacity for civic participation at the Union level**

Due to some delays linked with the Covid-19 situation, the payment needs until the end of the year have decreased.. Therefore, an amount of EU 4,2 million in payment appropriations can be made available.

## **Increased 19 02 01**

### **Response to crisis and emerging crisis**

The implementation of the Instrument contributing to stability and peace is progressing more rapidly than previously estimated. Based on the revised forecast, a reinforcement of EUR 35 million is needed to proceed with cost claims and first pre-financings due in 2020.

## **Decreased 19 04 01**

### **Improving the reliability of electoral processes, in particular by means of election observation missions**

As the actions linked to the Election Observation Missions (EOMs) take mainly place in the countries where the elections occur, this budget line was hugely affected by the consequences of the Covid-19 pandemic. Many missions were cancelled, delayed and changed. Therefore, EUR 28,5 million in payment appropriations can be made available.

## **Increased 19 05 01**

### **Cooperation with third countries to advance and promote Union and mutual interests**

Based on the revised forecast of payment, a reinforcement of EUR 3 million is requested to proceed with cost claims and first pre-financings, and to cover most urgent needs before the end of 2020.

## **Decreased 20 02 01**

### **External trade relations, including access to the markets of third countries**

The deployment and operation of the system for screening of foreign direct investments (FDI) has been delayed from last quarter of 2020 to first or second quarter of 2021. The signature of the framework contract is now foreseen for the end of November instead of September 2020. The commitment and the signature of the specific contract should follow shortly thereafter. This means that some of the payments will be delayed and processed only in 2021. In addition, costs have decreased since many events have been cancelled due to the Covid-19 pandemic, or have been replaced by virtual meetings.

For these reasons an amount of EUR 0,5 million in payment appropriations can be made available .

## **Decreased 20 02 77 02**

### **Pilot project -- Women and trade: creating a model chapter on gender in free trade agreements based on data on women participating in trade and women participating in the domestic economy**

The final payment for one project was lower than estimated (EUR 18 037 instead of EUR 80 000). The unspent budget is mostly related to lower expenditure for in-country surveys, travel and translation. Moreover, the final payment for another project will be due only at the beginning of 2021. As a consequence, an amount of EUR 111 963 in payment appropriations can be made available.

## **Increased 21 02 01**

### **Cooperation with Latin America**

The overall shortage of payment appropriations on the line is estimated at EUR 44 million. It is mainly linked to the need to frontload disbursements of budget support, normally planned for 2021, in order to allow partner countries to take immediate measures in the context of the Covid-19 pandemic. The countries affected are Honduras, El Salvador, Nicaragua and Peru.

Part of the needs (EUR 28 million) will be covered through a Commission autonomous transfer. In addition, an amount of EUR 5 million in payment appropriations is requested in the Global Transfer to cover most urgent payments needed before the end of 2020.

## **Increased 21 02 02**

### **Cooperation with Asia**

The overall shortage of payment appropriations on this budget line is estimated at EUR 126,5 million. It is mainly linked to the need to frontload disbursements of budget support, normally planned for 2021, in order to allow for immediate response to the Covid-19 pandemic. The countries affected are Nepal, Myanmar and Cambodia.

Part of the needs (EUR 41,5 million) will be covered through a Commission autonomous transfer. In addition, an amount of EUR 35 million is requested through the Global Transfer, and a reinforcement of EUR 50 million will be requested in the Draft Amending Budget 10 to cover most urgent payments needed before the end of 2020.

## **Increased 21 02 03**

### **Cooperation with Central Asia**

The shortage of payment appropriations on this budget line is mainly linked to the need to frontload disbursements of budget support, normally planned for later years, in order to allow for immediate response to the Covid-19 pandemic. The countries affected are Tadzhikistan and Uzbekistan. A reinforcement of EUR 6 million is requested through the Global Transfer. In addition, an amount of EUR 15 million will be requested in the Draft Amending Budget 10 to cover most urgent payments needed before the end of 2020.

## **Increased 21 02 04**

### **Cooperation with the Middle East**

The shortage of payment appropriations on this budget line is mainly linked to the need to frontload disbursements of budget support, normally planned for later years, in order to allow for immediate response to the Covid-19 pandemic in Yemen. A reinforcement of EUR 20 million in payment appropriations is therefore requested in the Global Transfer to cover most urgent payments needed before the end of 2020.

## **Increased 21 02 20**

### **Erasmus+ -- Contribution from the development cooperation instrument (DCI)**

Following the updated forecasts received from the National Agencies (NA) implementing the Erasmus+ programme, additional payment appropriations are needed in order to pay the pre-financings requested by the NA and to ensure a smooth running of Erasmus+ activities. A reinforcement of EUR 2 million is therefore needed.

## **Increased 21 04 01**

### **Enhancing the respect for and observance of human rights and fundamental freedoms and supporting democratic reforms**

Due to the Covid-19 crisis, a lot of contracting was frontloaded and more advance payments executed. Moreover, the funds not yet contracted at country level from the 2019 commitments (EUR 32 million) will be contracted by the end of 2020, which will also entail additional advance payments. A reinforcement of EUR 10 million is therefore needed, of which EUR 1 million will be implemented through a Commission autonomous transfer, and an amount of EUR 9 million is requested in the Global transfer.

## **Decreased 21 06 01**

### **Promotion of a high level of nuclear safety, radiation protection and the application of efficient and effective safeguards relating to nuclear material in third countries**

Actions relating to the Instrument for Nuclear Safety Cooperation (INSC) have been severely impacted by the ongoing Covid-19 crisis. The nature of INSC operations (field visits, training of personnel, supply of equipment, safety assessments etc.) means that the implementation of a majority of projects has slowed down significantly. Therefore, the revised forecasts indicate that an amount of EUR 12 million in payment appropriations can be made available.

## **Decreased 21 08 01**

### **Evaluation of the results of Union aid and follow-up and audit measures**

The surplus in payment appropriations is mainly due to two factors:

- some contracts (result oriented monitoring and evaluations) cannot be finalized in 2020 due to the Covid-19 crisis and the pre-financing payments initially envisaged cannot be paid;
- some contracts that were postponed from 2019 to 2020, were in turn delayed now due to the Covid-19 crisis with an impact on the use of 2020 payment appropriations.

Therefore, a total amount of EUR 9 million can be made available, of which EUR 2,5 million will cover needs through a Commission autonomous transfer. An amount of EUR 6,5 million can be made available for the Global transfer.

## **Decreased 21 08 02**

### **Coordination and promotion of awareness on development issues and on the enlargement and neighbourhood policies**

The finalisation of some contracts was delayed due to the Covid-19 crisis. Therefore, a total amount of EUR 2,5 million can be made available, of which EUR 1,3 million will cover needs through a Commission autonomous transfer. An amount of EUR 1,2 million can be made available for the Global transfer.

## **Decreased 21 09 51 01**

### **Asia**

The surplus of EUR 0,4 million in payment appropriations is due to over-optimistic forecasting. An amount of EUR 0,2 million will cover needs through a Commission autonomous transfer. Therefore, an amount of EUR 0,2 million can be made available for the Global transfer.

## **Decreased 21 09 51 02**

### **Latin America**

The surplus of EUR 1 million in payment appropriations is due to over-optimistic forecasting. An amount of EUR 0,1 million will cover needs through a Commission autonomous transfer. Therefore, an amount of EUR 0,9 million can be made available for the Global transfer.

## **Increased 22 02 03 02**

### **Support for economic, social and territorial development and related progressive alignment with the Union acquis**

The remaining part of the commitment for the 2016 special measure to support refugees in Turkey has to be paid to the EU Regional Trust Fund in Response to the Syrian crisis (EUTF Madad). The timely payment of this invoice is important in the context of the frontloading of operations as part of the Global Response to the Covid-19 crisis, as announced in the early summer for the Madad Trust Fund's activities. The payment implementation of the EUTF Madad in 2020 was much higher than expected at the time of the establishment of the Draft Budget 2020. Therefore, a reinforcement of EUR 100 million is requested in the Global transfer.

Moreover, there is a need for additional payment appropriations under this budget line due to reprogramming, increase of pre-financing payments and of indirect management mode with the beneficiary country in order to speed up payments to address the Covid-19 crisis. This additional reinforcement of EUR 90 million in payment appropriations will be requested in the Draft Amending Budget 10.

## **Increased 22 04 01 01**

### **Mediterranean countries -- Human rights, good governance and mobility**

In order to help partner countries deal with the economic, social and health consequences of the Covid-19 crisis, the Commission has been modifying on-going programmes in order to speed up their implementation and the related payments. In particular, the requirements for the disbursement of budget support tranches of a programme for Morocco have been modified. Therefore, a reinforcement of EUR 52 million in payment appropriations is needed, of which EUR 15 million will be covered through a Commission autonomous transfer, and EUR 37 million is requested in the Global transfer.

## **Increased 22 04 01 02**

### **Mediterranean countries -- Poverty reduction and sustainable development**

In order to help partner countries deal with the economic, social and health consequences of the Covid-19 crisis, the Commission has been modifying on-going programmes in order to speed up their implementation and the related payments. In particular, several budget support programmes for Morocco, Tunisia, Jordan and Algeria have been topped-up and their requirements for disbursement have been modified. In addition, other on-going regional and national programmes for the benefit of small and medium enterprises for example have been topped up and related payments increased and accelerated.

Therefore, an overall reinforcement of EUR 325 million in payment appropriations is needed, of which EUR 25 million will be covered through a Commission autonomous transfer, EUR 79 million are requested in the Global transfer, and EUR 221 million will be requested in the Draft Amending Budget 10.

## **Increased 22 04 02 01**

### **Eastern Partnership -- Human rights, good governance and mobility**

In order to help partner countries deal with the economic, social and health consequences of the Covid-19 crisis, the Commission has been modifying on-going programmes in order to speed up their implementation and the related payments. In particular, several budget support programmes for Armenia have been topped-up and their requirements for disbursement have been modified. In addition, an on-going programme for the stabilisation and growth in Ukraine has been topped up and the related payments increased and accelerated.

Therefore, a reinforcement of EUR 38 million in payment appropriations is requested in the Global transfer.

## **Increased 22 04 02 02**

### **Eastern Partnership -- Poverty reduction and sustainable development**

In order to help partner countries deal with the economic, social and health consequences of the Covid-19 crisis, the Commission has been modifying on-going programmes in order to speed up their implementation and the related payments. In particular, several budget support programmes for Armenia and Georgia have been topped up and their requirements for disbursement have been modified. In addition, several programmes for resilience and stability (Ukraine East, Armenia), for small and medium enterprises and businesses (Armenia) have been topped up and the related payments increased and accelerated.

Therefore, a reinforcement of EUR 137 million is needed, of which EUR 72 million is requested in the Global transfer and EUR 65 million will be requested in the Draft Amending Budget 10.

## **Increased 22 04 03 01**

### **Cross-border cooperation (CBC) -- Contribution from Heading 4**

When preparing the budget, the Commission did a prudent estimation of the needs for payment appropriations on this budget line, in light of previous years' implementation and experience with the accuracy of Member States' forecasts. However, project implementation has gathered speed in 2020 and the Managing Authorities have requested the full amount of pre-financing due in 2020. A reinforcement of EUR 24 million in payment appropriations is therefore needed.

## **Increased 22 04 03 04**

### **Other multi-country cooperation in the neighbourhood -- Supporting measures**

There are increased payment needs related to regional measures put in place to help partner countries in the Neighbourhood deal with the economic and social consequences of the Covid-19 crisis. Therefore, a reinforcement of EUR 13 million in payment appropriations is needed, of which EUR 8 million will be covered through a Commission autonomous transfer, and EUR 5 million is requested in the Global Transfer.

## **Decreased 23 03 01 01**

### **Disaster prevention and preparedness within the Union**

The payment forecast has been reduced by EUR 60 million for the following reasons:

- Member States requested lower level of pre-financing on the stockpiling contracts;
- Delays in the purchase of 2 Canadairs, resulting in the postponement to 2021 of the pre-financing initially foreseen for 2020;
- Delays in the implementation of some grant contracts, which result in having to postpone the interim and final payments to 2021;
- Signature and pre-financing of the medical evacuation services (Medevac) contract with Germany postponed to 2021;
- Some final payments related to 2016-2017 contracts were not paid (or partially paid) following analysis of final report.

## **Decreased 23 03 77 04**

### **Preparatory action -- Network of European hubs for civil protection and crisis management**

An amount of EUR 17 750 in payment appropriations can be made available because the contract, which has been closed, resulted in a lower consumption of funds.

## **Decreased 24 02 01**

### **Preventing and combating fraud, corruption and any other illegal activities affecting the Union's financial interests**

Due to the Covid-19 measures, OLAF could not implement the budget related to the Hercule programme as planned. In the course of 2020, it was not possible to organise the planned conferences and the Digital Forensic & Analyst trainings, OLAF's flagship. Therefore, an amount of EUR 1 million can be made available.

## **Decreased 26 02 01**

### **Procedures for awarding and advertising public supply, works and service contracts**

Following the postponement of the eNotices2 project, initially planned in 2019 and launched in May 2020, some payments will be postponed to 2021. Therefore, an amount of EUR 250 000 can be made available.

## **Increased 26 03 01**

### **Interoperability solutions and common frameworks for European public administrations, businesses and citizens (ISA<sup>2</sup>)**

A reinforcement of EUR 6 million in payment appropriations is needed for the following reasons:

- The accelerated implementation rate of the programme due to the end of the current Multiannual Financial Framework;
- Many projects are catching up previous years' delays;
- More short-terms contracts have been signed than initially planned, leading to faster implementation rate.

## **Increased 26 03 77 06**

### **Preparatory action -- Governance and quality of software code -- Auditing of free and open-source software**

Based on an updated estimation, a reinforcement of EUR 172 000 is needed to pay the invoices due by the end of the year.

## **Increased 26 03 77 09**

### **Preparatory action -- Data analytics solutions for policymaking**

Based on an updated estimation, a reinforcement of EUR 15 000 is needed to pay the invoices due by the end of the year.

## **Decreased 29 02 01**

### **Providing quality statistical information, implementing new methods of production of European statistics and strengthening the partnership within the European Statistical System**

Difficulties in the implementation of the ongoing grants for actions awarded to National Statistical Institutes due to the Covid-19 pandemic will lead to the postponement of payments to 2021. In addition, pre-financings originally planned for the end of 2020 will be postponed due to some delays in the publications and signature of the grant agreements. Therefore, an amount of EUR 6 million can be made available.

## **Decreased 32 02 01 01**

### **Further integration of the internal energy market and the interoperability of electricity and gas networks across borders**

The energy strand of the Connecting Europe Facility was increased in both commitments and payments during the conciliation procedure of the budget 2020. Commitment appropriations were used in 2020 as the calls for proposals were launched during the year. However, the related first pre-financings will only take place in 2021. Therefore, an amount of EUR 18,5 million in payment appropriations can be made available.

## **Decreased 32 02 01 02**

### **Enhancing Union security of energy supply**

The energy strand of the Connecting Europe Facility was increased in both commitments and payments during the conciliation procedure of the draft budget 2020. Commitment appropriations were used in 2020 as the calls for proposals were launched during the year. However, the related first pre-financings will only take place in 2021. Therefore, an amount of EUR 5,8 million in payment appropriations can be made available.

## **Decreased 32 02 01 03**

### **Contributing to sustainable development and protection of the environment**

The energy strand of the Connecting Europe Facility was increased in both commitments and payments during the conciliation procedure of the draft budget 2020. Commitment appropriations were used in 2020 as calls for proposals were launched during the year. However, the related first pre-financings will only take place in 2021. Therefore, an amount of EUR 5,8 million in payment appropriations can be made available.

## **Increased 32 02 10**

### **Agency for the Cooperation of Energy Regulators (ACER)**

The Agency faces a steep increase in appeals against its decisions stemming from the implementation of the new Clean Energy Package. Needs for the first half of the year have been funded through savings, but savings identified for the second half of the year are insufficient to cover the remaining needs, in particular legal counsel and translation services for decisions and appeals. Therefore, a reinforcement of EUR 0,4 million is requested.

## **Decreased 32 02 52**

### **Completion of energy projects to aid economic recovery**

Due to the Covid-19 crisis, the progress in the implementation of the last projects is slower than expected, thus creating delays in the submission of payment requests. Therefore, the revision of payment forecast indicates a surplus of EUR 27 million that can be made available.

## **Decreased 32 03 01**

### **Nuclear safeguards**

Due to the Covid-19 crisis, some deliveries of instruments, equipment and material foreseen initially before December 2020 will be delivered after this date and thus paid in 2021. There is also a decrease of the budget needed for the inspection missions. Therefore, an amount of EUR 3 million in payment appropriations can be made available.

## **Decreased 32 03 03**

### **Nuclear decommissioning assistance programme in Lithuania**

Due to the Covid-19 crisis, the anticipated acceleration of the implementation of the decommissioning programmes did not materialise. This affected the physical delivery of material and presence of foreign experts on site. It also delayed pre-financings paid by Euratom in relation to procurement procedures that were extended, delayed or suspended to alleviate economic operators and national authorities constraints. Therefore, an amount of EUR 13,8 million in payment appropriations can be made available.

## **Decreased 32 03 04 01**

### **Kozloduy programme**

Due to the Covid-19 crisis, the anticipated acceleration of the implementation of the decommissioning programmes did not materialise. This affected the physical delivery of material and presence of foreign experts on site. It also delayed pre-financings paid by Euratom in relation to procurement procedures that were extended, delayed or suspended to alleviate economic operators and national authorities constraints. Therefore, an amount of EUR 16,9 million in payment appropriations can be made available.

## **Decreased 32 03 04 02**

### **Bohunice programme**

Due to the Covid-19 crisis, the anticipated acceleration of the implementation of the decommissioning programmes did not materialise. This affected the physical delivery of material and presence of foreign experts on site. It also delayed pre-financings paid by Euratom in relation to procurement procedures that were extended, delayed or suspended to alleviate economic operators and national authorities constraints. Therefore, an amount of EUR 23,6 million in payment appropriations can be made available.

## **Decreased 32 04 03 01**

### **Making the transition to a reliable, sustainable and competitive energy system**

Due to the Covid-19 crisis the progress of several projects was delayed leading to a postponement in the requests for interim payments. In addition, the signature of grant agreements was also delayed, leading to a postponement in the requests for pre-financing. Therefore, an amount of EUR 52 million in payment appropriations can be made available.

## **Increased 33 02 01**

### **Ensuring the protection of rights and empowering citizens**

A reinforcement of EUR 4,6 million in payment appropriations is needed to honour outstanding and future legal commitments and for pre-financings of the projects from 2020 calls for proposals.

## **Increased 33 02 02**

### **Promoting non-discrimination and equality**

A reinforcement of EUR 3 million in payment appropriations is needed to honour outstanding and future legal commitments and for pre-financings of the projects from 2020 calls for proposals.

## **Increased 33 03 01**

### **Supporting and promoting judicial training and facilitating effective access to justice for all**

A reinforcement of EUR 7 million in payment appropriations is needed to honour outstanding and future legal commitments and for pre-financings of the projects from 2020 calls for proposals.

## **Increased 33 03 02**

### **Facilitating and supporting judicial cooperation in civil and criminal matters**

A reinforcement of EUR 7 million in payment appropriations is needed to honour outstanding and future legal commitments and for pre-financings of the projects from 2020 calls for proposals.

## **Decreased 33 03 77 08**

### **Preparatory action -- Capacity building, programmatic development and communication in the context of the fight against money laundering and financial crimes**

A call for tenders was launched combining the budget of 2019 (EUR 1 million) and 2020 (EUR 750 000) for this preparatory action. The deadline for submission of tenders is 8 October and therefore the payment appropriations will not be used this year and an amount of EUR 0,7 million can be made available.

A reinforcement of EUR 0,7 million in payment appropriations is needed to honour outstanding and future legal commitments as well as for pre-financings of projects from 2020 calls for proposals .
