The outcome of the Committee's work on preparing the first reading is recorded in documents 11427/07 FIN 332 + ADD 1 and 11428/07 FIN 333 + ADD 1 + ADD 2; in this context the German delegation states that it is able to join the existing qualified majority, the Spanish delegation voices its preoccupation over funding for Frontex and several delegations express strong reticence regarding the cuts proposed to the research funding in sub-Heading 1a. The Commission reiterates her preoccupation concerning Heading 5. The Committee then notes the practical details announced by the Presidency regarding the timing and content of the conciliation meeting with the European Parliament.

The Presidency compromise proposal set out in Annex I of document 11322/07 received the support of a sufficient number of delegations to allow for its adoption by qualified majority. However, it was rejected by the Commission. Stating the impossibility for the Council to act unanimously against the negative Commission opinion, the Presidency withdrew the compromise proposal.

It was concluded that the Council would be invited to confirm, as an "A" point at its meeting of 16 July 2007, the lack of the qualified majority required to act on the Commission proposal set out in document 10783/07 or to indicate that the Council opposes this proposal.
