Statement by the Commission:

“In line with the Commission statements at the time when the Council adopted in 2022 the decision authorising the opening of negotiations with Ukraine for the original agreement on the carriage of goods by road signed on 29 June 2022, when the Council adopted the decision on signature and provisional application of that agreement, and when the Council adopted the decision on the conclusion of that agreement, the Commission would like to make the following statement:

1. The Commission considers that any agreement on the carriage of goods between the European Union and Ukraine aimed at regulating the mutual access to the road freight transport market falls within the exclusive external competence of the Union referred to in Article 3(2) TFEU, even where that agreement may be limited in time. The conclusion of international agreements on road transport of goods is explicitly provided for in a legislative act of the Union (Article 1 of Regulation (EC) No 1072/2009[1]). Second, the conclusion of such agreement may affect common rules or alter their scope, in line with Article 3(2) TFEU, as interpreted by the ECJ jurisprudence [2]. The fact that the envisaged agreement is intended to be limited in time and directly aims to specifically address repercussions of Russia’s unprovoked and unjustified military aggression against Ukraine does not change the nature of the competence exercised by the Union.
2. The Court has stated[3] that Protocol 25 does not apply to Article 3(2) TFEU and cannot be read to limit its scope. Thus, the principle of pre-emption under that article is broader than under Article 2(2) TFEU.
3. The Commission considers that the Court of Justice has clarified in its judgment of 9 April 2024 in case C-551/21 that ensuring the signing of international agreements outside the area of the CFSP is a prerogative of the Commission in accordance with the Treaties. It is therefore not for the Council to lay down provisions as to the signing by the Commission of international agreements outside the area of the CFSP.
4. The Commission reserves all its rights as regards the above.
