#### **'I/A' ITEM NOTE**

From:	General Secretariat of the Council
To:	Permanent Representatives Committee/Council
Subject:	Council Implementing Decision and Implementing Regulation concerning restrictive measures in view of the situation in Libya

1. On 31 July 2015, the Council adopted Decision (CFSP) 2015/1333 concerning restrictive measures in view of the situation in Libya. On 18 January 2016, the Council adopted Regulation (EU) 2016/44 concerning restrictive measures in view of the situation in Libya.
2. On 18 July 2022, the United Nations Security Council ('UNSC') Committee established pursuant to UNSC Resolution 1970 (2011) amended the listing of one person subject to restrictive measures.
3. On 20 July 2022, the High Representative submitted to the Council proposals for a Council Implementing Decision (doc. 11545/22) and Council Implementing Regulation (doc. 11547/22) concerning restrictive measures in view of the situation in Libya.
4. On 29 July 2022, the Foreign Relations Counsellors Working Party agreed (through a written consultation) the texts of the draft Council Implementing Decision and Implementing Regulation.

5. In these circumstances, COREPER is invited to:

- confirm the agreement on draft Council Implementing Decision and Implementing Regulation;
- recommend that the Council adopt the draft Council Implementing Decision implementing Decision (CFSP) 2015/1333 concerning restrictive measures in view of the situation in Libya as set out, after finalisation of the text by the legal/linguistic experts, in document 11546/22 + ADD 1;
- recommend that the Council adopt the draft Council Implementing Regulation implementing Regulation (EU) 2016/44 concerning restrictive measures in view of the situation in Libya as set out, after finalisation of the text by the legal/linguistic experts, in document 11548/22 + ADD 1;
- recommend that the Council approve the notice to be published in the Official Journal ('C' Series), as set out in Annex I to this note;
- recommend that the Council approve the notice for the attention of data subjects to be published in the Official Journal ('C' Series), as set out in Annex II to this note.

The purpose of the processing operation is the establishment and updating of the list of persons subject to restrictive measures in accordance with Council Decision (CFSP) 2015/1333 as implemented by Council Implementing Decision (CFSP) 2022/xxx<sup>1</sup>, and Council Regulation (EU) 2016/44, as implemented by Council Implementing Regulation (EU) No 2022/xxx<sup>2</sup>.

The data subjects are the natural persons who fulfil the listing criteria as laid down in Council Decision (CFSP) 2015/1333 and Council Regulation (EU) 2016/44.

The personal data collected includes data necessary for the correct identification of the person concerned, the statement of reasons and any other data related thereto.

The personal data collected may be shared as necessary with the European External Action Service and the Commission.

Personal data will be retained for 5 years from the moment the data subject has been removed from the list of persons subject to the restrictive measures or the validity of the measure has expired, or for the duration of court proceedings in the event they had been started.

Without prejudice to any judicial, administrative or non-judicial remedy, data subjects may lodge a complaint with the European Data Protection Supervisor in accordance with Regulation (EU) 2018/1725 ([edps@edps.europa.eu](mailto:edps@edps.europa.eu)).
