- confirmed the Presidency revision to point (9) Article 19(1) as contained in doc. 11358/11:
- noted that these points completed the Presidency mandate for negotiation with the European Parliament with a view to the second informal trilogue scheduled for 22 June 2011;
- noted the Presidency's intention to reflect the outcome of this meeting in the form of a revised four column document to be shared with the European Parliament and the Commission (doc. 10143/1/1 REV 1);
- noted the LT request for which the Presidency noted significant support and indicated its willingness to mention it during the second informal trilogue.
