THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 91(1), 100(2), Article 207(4), first subparagraph, and Article 212, in conjunction with Article 218(6), second subparagraph, point (a), Article 218(7) and Article 218(8), first subparagraph, thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- In accordance with Council Decision (EU) .../...¹⁺, the Advanced Framework Agreement between the European Union and its Member States, of the one part, and the Republic of Chile, of the other part (the 'Agreement') was signed on ...⁺⁺, subject to the conclusion of the Agreement at a later date. In accordance with that Decision, the Joint Statement on the Provisions on Trade and Sustainable Development contained in the Advanced Framework Agreement between the European Union and its Member States, of the one part, and the Republic of Chile, of the other part, and the Joint Interpretative Declaration on the Provisions on Investment Protection contained in the Advanced Framework Agreement between the European Union and its Member States, of the one part, and the Republic of Chile, of the other part, both attached to the Agreement, were approved on behalf of the Union.
- (2) The Agreement should be approved on behalf of the Union.

- (3) Pursuant to Article 218(7) of the Treaty on the Functioning of the European Union, it is appropriate to authorise the Commission to approve on the Union's behalf certain modifications to the Agreement that are to be adopted by a simplified procedure pursuant to Articles 28.20 and 41.7(14) of the Agreement, and by a body set up by the Agreement pursuant to Article 32.34 and subparagraph (a)(x) of Article 8.5(1) thereof.
- (4) The Agreement does not, in accordance with Article 41.10 thereof, within the Union, confer rights or impose obligations on persons, other than those created between the Parties under public international law,

HAS ADOPTED THIS DECISION:

Article 1

The Advanced Framework Agreement between the European Union and its Member States, of the one part, and the Republic of Chile, of the other part¹⁺ is hereby approved on behalf of the Union.

Article 2

For the purposes of Article 28.20 of the Agreement, any modification or rectification of Annexes 28-A and 28-B to the Agreement shall be approved by the Commission on behalf of the Union.

Article 3

For the purposes of Article 32.34 and subparagraph (a)(x) of Article 8.5(1) of the Agreement, any amendment to Annex 32-C to the Agreement shall be approved by the Commission on behalf of the Union.

Article 4

For the purposes of Article 41.7(14) of the Agreement, the following shall be approved by the Commission on behalf of the Union:

- (a) any amendment to the appendices to the Agreement on Trade in Wines in Annex V to the Agreement establishing an association between the European Community and its Member States, of the one part, and the Republic of Chile, of the other part¹, signed on 18 November 2002 (the 'Association Agreement'), as incorporated into the Agreement;
- (b) any amendment to the appendices to the Agreement on Trade in Spirit Drinks and Aromatised Drinks in Annex VI to the Association Agreement, as incorporated into the Agreement.

Article 5

The President of the Council shall, on behalf of the Union, give the notification provided for in Article 41.5(1) of the Agreement, in order to express the consent of the Union to be bound by the Agreement².
