THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>1</sup>, and in particular Articles 23 and 24 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

#### Whereas:

- (1) By means of its Decisions of 21 September 2020<sup>1</sup>, of 11 December 2020<sup>2</sup>, of 13 April 2021<sup>3</sup>, of 21 June 2021<sup>4</sup> and of 21 September 2021<sup>5</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers (the "Committee") for the period from 25 September 2020 to 24 September 2022.
